

Huey P. Newton, Minister of Defense of the Black Panther Party for Self Defense, will appear in Alameda County Superior Court tomorrow at 9:00 am to enter a plea of not guilty to a trumped up charge of murder. Following the arraignment a support demonstration will be held on the front steps of the courthouse at 12th and Fallon Streets in Oakland. It is imperative for white activists to join with black militants to defend Huey P. Newton.

On October 28, Huey became but the latest victim of police oppression and brutality in the black ghettoes of America. Two Oakland cops tried to assassinate him and failed. Now the businessmen, landlords, and politicians — who use police to maintain their exploitative control — are attempting to lynch him "legally" through the rigged court system which they also control.



But Huey must not become another Leonard Deadwyler or Matthew Johnson; his "crime" was not just that he was black, but that he was political. As Minister of Defense for the Black Panther Party for Self Defense he was instrumental in organizing the movement for black liberation in the Bay Area and he had begun to make organizational ties with Stokely Carmichael and other national black power militants.

The political repression which victimized Huey P. Newton is part of a nationwide attempt by the rulers of America to crush the black liberation struggle by eliminating its leaders. In recent years Malcolm X was assassinated and Robert Williams was forced into exile. Now Rap Brown is under house arrest in New York City and Le Roi Jones has been sentenced to 21/2 years in prison.

Whites have been apathetic about these acts against blacks by the power structure because we believed we were safe from similar repression. However, with the initial arrests of Reverend Coffin, Doctor Spock, and the others who advocated draft resistance or refusal, it is obvious that several thousands of professors, students, lawyers, doctors, ministers, and others are now in imminent danger of immediate arrest for having obeyed the dictates of their consciences.



If we stand by silently while our cohorts and allies are eliminated from society, we will have no defense against the government's futher attempts to destroy our movements. We must not permit ourselves to be picked off one by one!

At a statewide meeting in Pasadena this past weekend the organizers of the Peace and Freedom Party recognized the common threat to the anti-war movement and the black liberation movement. They adopted a resolution to support the latest victims of government policy and called for mass actions against this repression.

#### AGAINST THE CAPITALIST SYSTEM FOR WORKERS CONTROL OF SOCIETY AND PRODUCTION!

The Labor Committee of the leace and Freedom Party believes that the copyright system — with its constant necessity to seek new markets in which to its act and its never-ending search for profits for the huge monopolies, corporations and banks — is the source of exploitation, poverty, racism and war in our coverty.

Until the working class and all those who genuinely wish to change this society begin to clearly understand this and to understand the reasons for it, there can be no real progress in bringing about that peace and freedom all of

us wish.

We state clearly and unequivocally that the working class, as defined above, is the true driving force of American society, that it must recognize its class interests and once and for all make a clean break with the parties of capitalism, the Democrats and Republicans, and organize its own party.

This party must be based on control by the rank-and-file in the places where they work as well as where they live, so that all the employed and unemployed

may have a voice.

The object of such a party, which may be called a Workers' Party or a Labor Party, must be to win control of the government and industry and to lay the foundations of a new society in which production and distribution will be for use instead of for profit.

Government would work to bring friendship among nations, using national and international resources to help the underdeveloped, oppressed nations.

#### PROGRAM

- 1. IA.MEDIATE AND UNCONDITIONAL WITHDRAWAL OF U.S. TROOFS FROM VIETNAM The people of Vietnam are fighting for their just and legitimate interests against a brutal and oppressive ruling class supported by U.S. Imperialism. "Negotiations" in any form would imply that the U.S. has some legitimate interest in Vietnam to negotiate.
- 2. 30 HOURS WORK FCR 40 HOURS IAY and RESTRICTIONS ON OVERTIME TO A AKE MORE JOBS FOR ALL One of the greatest dangers today is the creation of a large body of unemployed who have given up looking for work and are permanently dependent on welfare. While not opposing welfare, we should not give it political support. We must fight for the alternative of more jobs for all. Institution of the 30 hour week with no cuts in pay and new penalties on overtime would create new jobs and have the effect of uniting white and black workers for their common interests as workers.
- 3. PLANNING FOR A ONE-DAY WORK STOPPAGE AGAINST THE WAR The anti-war movement must orient toward the working class where the actual PCWER to end the war lies. Instead of concentrating all its energy on organizing huge peace marches and confront-the-cops-type demonstrations by students, it must lay plans to encourage and mobilize the growing dissatisfaction among members of the working class toward an eventual one-day work stoppage.

The imperialist policies of the U.S. government — of which the war in Vietnam is at present the most dramatic manifestation — are fundamentally detrimental to the working class, above all other classes. Johnson cannot provide both 'guns and butter." It is workers that pay for the war — who most feel the economic squeeze resulting from the \$2,000,000,000 per month spent for destruction in Vietnam. Wage-freeze demands by the Johnson

administration can be expected in the near future. It is, furthermore, from the ranks of the working class that cannon-fodder is provided for the war in Vietnam.

This link between the dairy economic struggles of black and white workers and political issues, especially the war in Vietnam at present, must be emphasized. A perspective of eventually bringing our millions of workers in a general strike must replace the present limited perspectives of the movement.

4. ORIENT TOWARD FREEDOM AND LABOR STRUGGLES — WORK TOWARD THE CREATION OF A NATIONAL WORKERS' FARTY - PFF advocates the creation of a national political party of the rank and file to represent the interests of the working class - namely those who must depend on wages or solary to feed and clothe themselves and their families, those who live on pensions earned from employment and those who are forced to live on welfare because the present capitalist system has failed to provide employment for all.

PFF, because of the very diversity of the elements within it and its lack of a defined class base, is not that party. Such a party can only arise out of the rank and file struggles of labor and the racially-oppressed masses. IFF can, however, be a positive factor in promoting the growth of such a party by opposing the capitalist system and orienting toward the working class. It must support the interests of workers!

SUPLORT ARMED SELF-DEFENSE OF THE GHETTO. SUPPORT BLACK SELF-DETERMINATION. FREE HUEY NEWTON! - Miserable living conditions in the ghetto are made intolerable by the routine brutality of the cops — the real perpetrators of violence in the ghetto. Cops serve as the direct arm of repression for those who profit from the misery of the ghetto - the slumlords and land speculators, profit-mongering merchants and the big capitalists.

FFP demands that police officers be elected by the neighborhoods they


serve and be subject to recall by a vote of 1% of that neighborhood.

Ghetto residents should and must defend themselves from police oppression. Heavy Newton should be commended for doing just that. Because a fair trial for black people is impossible in a racist society, the demand must be: FREE HUEY NEWTON! PFF, furthermore, unequivocally supports Huey as a congressional candidate.

White workers must support Black workers. Labor with a white skin cannot be free while labor with a black skin is enslaved. The freedom of workers of both races is interdependent. The ruling class must not be allowed to continue pitting race against race for its own profit. Only by uniting these workers' struggles can either of them succeed.

6. WORKING CLASS TICKET - FFr can not support bourgeois liberal candidates for office and expect to break with the existing parties of capitalism. The Martin Luther Kings, the Dr. Spocks, and the Robert Scheers have not broken with the establishment on the basic issues that separate the interests of those who must work to live from those who own the means of production. Left liberalism supports the existing society. Only those candidates will be supported who represent the above program and the interests of the working class.

The Resistance is a group of young men who refuse to comply with the draft. They contend that the most effective action is to confront the Selective Service System directly, rather than leave the country, take a C.O. position, or use other methods of avoiding the draft.

Anyone carrying a draft card, regardless of the classification, can take The Resistance position. By turning his card in, the holder is openly declaring his refusal to cooperate with system, He is also subjecting himself to prosecution by the Federal Government with the then possible resulting penalty of up to five years in prison. #### FOUNDING CONVENTION

The Peace and Freedom Party held its State Founding Convention March 16th through 18th, in Richmond, California

The convention did not complete all its assigned tasks but it did accomplish a lot, and the results as well as the work left to be done are of immediate concern to all of us.

The convention voted to support the "Free Huey" demand, and the body have its support to the Black Panther Party Ten Point Program. This was the initial step toward fulfilling PFM's stated principle of full support for the black liberation movement.

Further, the convention agreed to "mount a statewide education campaign on the issue of 'Free Huey Newton'," and that the "PFM will conduct statewide demonstrations in support of Huey Newton."

The convention agreed to support Stop-the-Draft-Week, but it did not support any particular tactics. It was also decided to launch a state-wide 18-year-old vote initiative drive to place the issue on the November ballot.

Paul Jacobs, delegate from the Marina-Union Neighborhood Group, was nominated and endorsed as the PFM candidate for US Senator from California.

Our organizational meeting of the Marina - Union NG took place in early (M.U.N.G.) February, twelve persons attending. Since then we have grown to a body of 30 active members and 50 or so who attend meetings occasionally. Among the most important policies decided on in our NG is that of open meetings, where anyone regardless of party registration, age, or citizenship - is welcome to attend and vote. We feel strongly that, in order for us to incorporate the widest spectrum of opinion, we must not limit our membership to only those registered within the party.

WHAT ABOUT MFETINGS? - We meet every Tuesday evening at 7:30 at the home of Lloyd and Carol Baird (Lloya is our Co-Chairman), 2266 Bay Street. Meetings become a springboard for discussions on Vietnam policy, the draft, Huey Newton, Civilian Review Boards, Peace Demonstrations, etc. These discussions lead to policy and direct action proposals to be implemented locally, and often, county-wide.

This is all incorporated in the idea of Movement politics and is a lasting and long-range goal of the PFM.





# MASS MEMORIAL FEDERAL BUILDING THIS MONDAY APRIL 109 12: NOON

Reverend Martin Luther King dedicated his life to the poor, the oppressed, and the black victims of a racist American society. Yet at the Friday memorial service in San Francisco, the persons who spoke to commemerate his unparalleled service to the cause of freedom, equality, and justice were Congressmen, Mayors, Assemblymen, Bishops, and other individuals who continue to grow fat while those for whom Dector King died become more poor, more oppressed, and more victimized. A memorial conducted by the very men he struggled so hard against is a sham and is evidence of the hypocracy of this racist society at its worst.

The racist Fstablishment will attempt to continue pitting black against white to insure the continuation of the decadence which is the life blood of the rulers of America. We must guard against this and be prepared to give our lives, as did our brother, to insist that our just demands be heard and satisfied NOW:

Martin Luther King spoke to all men, but he did not speak for all men, and the oppressed peoples of the world for whom he spoke and gave his life shall speak out and publically mourn the passing of one of the great men of history. Therefore we have called this Mass Memorial conducted by and for the people who, with their sweat, and their tears, and their blood, shall refuse to permit his brutal murder to fade into the history books. There is but one way to insure that the too short life of this man be justified—WE MUST MAKE HIS DREAMS FOR US COME TRUE!

#### Therefore we demand that:

- All normal business functions in San Francisco shall cease on Monday, April 8.
- All political prisoners be immediately set free--including Huey Newton, Rap Brown, LeRoi Jones, and Cleveland Sellers.
- 3. The 10-point program of the Black Panther Party for Self Defence be immediately implemented.
- The recommendations of the President's Riot Commission be immediately implemented.
- 5. To help accomplish the above demands, all United States armed forces must immediately be withdrawn from Southeast Asia and the money being squandered on the military-industrial complex must be given to the colonized people of America.

#### IT IS NOT ENOUGH TO MOURN

#### IN MEMORY OF MARTIN LUTHUR KING---END RACISM NOW!

The official mourners of Dr. Martin Luther King, from Lyndon Baines Johnson on down; are doing their best to make the nation forget that King died a victim in the struggle against white racism. That is understandable since these official mourners are themselves the beneficiaries and defenders of this system that Dr. King fought in his own way and with his own methods. Pious resolutions and proclamations are cheap. They cost Establishment politicians nothing. We believe that it is time to separate the pious frauds from those who genuinely shared Martin Luther King's aims even when they differed with him on the methods used to reach those goals. We propose that the political leaders who now mourn King take advantage of the emotional climate create by King's death and begin an immediate attack on the racist institutions he died fighting. If they refuse to initiate such a MARTIN LUTHER KING MEMORIAL PROGRAM TO END RACISM NOW they will only confirm the suspicions that already exist in the minds of most black people. Whether these political charaltans are forced to move out of fear of the consequences or not we propose to organize our own demonstrations around these demands. We intend to pack every local city council meeting and board of supervisors meeting this week and demand that they address themselves to this program:

#### END THE POLICE REIGN OF TERROR IN THE GHETTO

- 1. We demand that Eldridge Cleaver and the other victims of police terror be freed immediately.
- 2. We demand the removal of the white racist police force from the ghetto. As a first step in this direction we demand the immediate institution of POLICE CONTROL COMMISSIONS locally elected with the ability to perform by law the patrolling and checking of police now carried on informally by the Black Panther Party.
- 3. We demand the immediate isarming of the police and the outlawing of the use of MACE and other chemical weapons.
  - 4. We demand that all public officials and bodies place themselves on record NOW as being opposed to the deployment of National Guard or Federal troops in black communities.

#### FULL EMPLOYMENT AND AN IMMEDIATE END TO RACIST DISCRIMINATION IN EMPLOYMENT

- 1. We demand an immediate program of public works to provide jobs for unemployed black people at union wages.
- 2. We demand an immediate attack on racist discrimination on the part of of employers and trade union officials. Such acts of discrimination should be made criminal offenses.
- We demand that all public contracts should in the future provide for substantial minority employment we further demand that all current contracts which do not provide for substantial minority employment should be suspended until the situation is corrected.

AN END TO DISCRIMINATION IN HOUSING AND AN END TO RENT GOUGING: FOR DEMOCRATICALLY PLANNED AND CONTROLLED PUBLIC HOUSING

- 1. We demand the institution of rent control to end landlock exploitation of ghetto and other low-income families.
- 2. We demand the OUTLAWING of ALL discrimination in housing. Builders and Real estate operators who discriminate should have their licenses suspended and should apply to ALL rousing as is the casewith present "fair housing" bills.
- 3. We demand the suspension of present urban renewal programs that destroy the homes of ghetto residents and replace them with housing the former residents cannot afford.
- 4. We demand local democratic control of public housing programs, rent subsidies and other measures to provide decent housing for all.

END RACIST INJUSTICE: ABOLISH THE GRAND JURY SYSTEM: FREE HUEY NEWTON

END THE DEGRADING AND RACIST WELFARE SYSTEM; FOR A WELFARE SYSTEM FIT FOR HUMAN BEINGS

- We demand that welfare payments be increased to \$350 a month for individuals and at least \$650 a month for families. Payments to be made immediately upon application.
- 2. We demand an end to the interference with the personal and civil liberties for welfare recipients. Abolish the "no-man-in-the-house" regulation.

#### END RACISM IN EDUCATION NOW

- 1. We demand a massive program of education and training to prepare minority students for high-paying skilled occupations.
- 2. We demand the doubling of all funds spent for minority education .
- 3. We demand that the curriculum include courses in Black culture and history.
- 4. We demand community control of schools.

REIES TIJERINA, who has been proposed as Vice Presidential candidate of the Peace and Freedom Party, and Southwest Steering Committee President for the Poor People's March on Washington, has been jailed on phony charges on the eve of his departure for Washington, D. C.

- \* On April 27, in what appears to be a calculated move to remove radical leadership from the Poor People's March, the District Attorney of Santa Fe, New Mexico dredged up a case against Tijerina and 13 other Alianza members which had been dismissed by court action earlier this year. (The original case referred to the symbolic act of Tijerina and other Alianza members in 1966 in laying just claim to lands guaranteed to Spanish-speaking residents of the Southwest by the Treaty of Guadalupe Hidalgo - - by bringing to mock trial two forest rangers for trespassing on Pueblo property; the rangers were fined \$50, the sentence was suspended, and the rangers were released. In October, 1966, the District Attorney of Santa Fe brought charges of "kidnapping" against Tijerina and other members of the Alianza, and asked for the death penalty. In January, 1968, presiding Judge Joe Angel dismissed the case after Charles Solomon, for the American Civil Liberties Union, pointed out to the court that the definition of "kidnapping" did not apply).
- \* Three days before Dr. Martin Luther King was assassinated, Reies Tijerina was with him in Atlanta, preparing the details for the Poor Peoples March. After Dr. King named Tijerina Southwest Steering Committee President of the Poor People's March, political harassment began; the latest episode occurred on April 21st when an expolice officer attempted to dynamite Alianza headquarters in Albuquerque. On April 27, the District Attorney hastily convened a Grand Jury which over-ruled Judge Angel's dismissal of the case against Tijerina. Tijerina was immediately jailed; police officers stormed into an Alianza dance in Albuquerque to seek out others; 13 members of the Alianza were jailed also.
- \*A local spokesman for the Alianza stated today that the action was "an attempt on the part of federal authorities to keep Tijerina in jail as long as possible in order to prevent his participation in the Poor People's March. "
- \*The Brown-Black Coalition of the Peace and Freedom Party was meeting in Richmond Sunday when word came of Tijerina's arrest. Manuel Gomez, Chairman of the Brown Coalition, was instructed to send telegrams of protest to the President of Mexico, the Legislature of Mexico, the United Nations, the Governor of New Mexico, and all

Spanish language newspapers in the U. S. Chicano groups have scheduled a large protest rally at the University of California and are making a public appeal for bail money so Tijerina may be immediately released to resume the responsibility that Dr. King conferred on him for the march in Washington. - \* Last night, the County Council of the ALAMEDA CCUNTY PEACE AND FREEDOM MOVEMENT, passed a resolution of support for Tijerina and other Alianza leaders, appointed a committee to send letters of protest to all relevant government authorities, and to plan a massive demonstration against this latest instance of decapitating the leadership of poor people in the U.S.
- \* Spokesmen for the Black-Brown Coalition, the Black Panther Party, and the Peace and Freedom Movement stated today that the pattern of assassination or incarceration of radical black and brown leaders is becoming blatantly visible: Medgar Evans, Malcolm X, Huey Newton, Gilberto Garza, H. Rap Brown, Charles de Baca (Garza and de Baca were among the 12 Latin youths fatally assaulted by police in the past year). Most recently, the murder of Martin Luther King and Bobby Hutton, the harassment and incarceration of David Sanchez (Prime Minister of the Brown Berets, Los Angeles) and of Eldridge Cleaver (Minister of Information, Black Panther Party); the trumped up suit against Bobby Seale, Chairman of the Black Panther Party - and now Reies Tijerina. Peace and Freedom people regard these cases as political oppression which encompasses the Peace and Freedom Party since many of these leaders are candidates of Peace and Freedom: Huey Newton is P & F candidate for U. S. Congress; Bobby Seale is the P & F candidate for the State Legislature, 17th A.D.; and Reies Tijerina, proposed P & F candidate for the Vice-Presidency.

#### WHY WAIT FOR THE CONVENTION?

The route McCarthy supporters take today is the same route that the peace movement has tred before. McCarthy supporters were among those who built barricades in the streets of Oakland during Stop the Draft Week and who occupied buildings at Columbia. Today McCarthy supporters march to show the California delegates to the Democratic Convention that Californians support McCarthy.

Significantly McCarthy began his campaign for President by saying it was designed to move protestors off the streets into normal electoral channels. Moreover, the pressure of you the people has influenced his campaign. In December McCarthy said he would keep troops in Vietnam five years after successful negotiations. By the end of the California primary he came close to calling for immediate withdrawal of troops. Close, but not to that point, for that is the difference between being in the Democratic Party and trying to woo the politicians, and breaking away to form a new party based on the movements.

There has been talk among certain leaders of the McCarthy campaign such as Waskow and Raskin, of a "third presidential ticket". This "third ticket" means a partial break from the Democratic Party this year only and supporting local Democrats, to eventually return to the Democratic Party. McCarthy himself has been decidedly cool to this proposal. To this we put forward California Peace and Freedom Party. On the other hand among McCarthy supporters such as on this march, there is a healthy feeling for a third party. Peace and Freedom is that party as it has the basic politics which will further the movements. Peace and Freedom is based on the anti-war and black liberation movements and will not relinquish the streets during the election campaign out of fear of scaring away the voters. More importantly the Peace and Freedom Party will be around after November.

The Peace and Freedom Party calls for an Immediate Withdrawal of Troops from Vietnam, and opposes the whole thrust of American foreign policy which led us there in the first place. We must prepare the American people now to resist another war, whether it be in Korea, Bolivia or elsewhere, which seems a likely possibility for the future.

The Peace and Freedom Party supports the Black Liberation Movement as led by groups like the Black Panthers. Through a meaningful coalition like that between Peace and Freedom and the Panthers and militant chicanos, each recognizing the integrity of the other, both movements can prosper and aid each other. A minimal demand in support of the black liberation movement is that Huey Newton and other political prisoners must be set free.

Though McCarthy and Kennedy won virtually every primary they took part in, largely because Americans want an end to the war in Vietnam and a progressive solution to the ghettoes rather than repression (which is not to say that McCarthy and Kennedy wanted this), the Democratic Party politicians have selected Humphrey in all states without primaries. The Democratic Party is being revealed for what it always has been, an undemocratic party, controlled by unresponsive politicians committed to the corporate Establishment, Attempts to reform the Democratic Party of war and racism are doomed to failure because the power structure has set the rules of the game.

We invite you to join us in the Peace and Freedom Party now. Work with us up to the Democratic Convention, to the elections and most importantly after November in general movement activities and in their electoral expression. Work with us on some of the problems facing San Francisco: by circulating the rent and tax control petitions, supporting the Muni fare fight and defending the hip community from police attack. Of course we're on the ballot in California and will be soon in Illinois and New York. But more importantly, we have set up a democratic structure to insure that the membership and not the elected officials control of the party. We urge you to join your local neighborhood group of the Peace and Freedom Movement and help make decisions. Help us build a real, permanent, radical alternative to the status quo.

#### PFM ON THE WAR AND NEGOTIATIONS

The PFM stands for immediate withdrawal from Vietnam. The only issue in the war is whether or not the Vietnamese have the right to settle their own affairs. The deny them that right when American soldiers fight and American diplomats negotiate the future of Vietname Either we allow the Vietnamese people complete sovereignty or we allow them none. There is no middle position when national self-determination is at stake. We believe that the U.S. had no legal or moral right to become involved in the civil conflict in southern Vietnam and has no right, today, to participate in any way in the development of the future of Vietnam.

The history of our involvement has become well known in recent years and few people believe that the U.S. is in SE Asia to protect a small democracy from the menace of communism. Polls show that a large proportion of the population believes that we never would have become involved. After conceding this, some people then go on to say that, as unfortunate as it is, we are there and cannot pull out. This position means that the U.S. must perpetuate the the original mistake. These people urge that we change our tactics and try to help the Vietnamese in a different way. The PFM maintains that the U.S. can best help the Vietnamese by withdrawing and letting them decide their own affairs. Anything less, legally, is a violation of their sovereignty and, realistically, represents the U.S. desire to maintain a permanent position of power in Vietnam. By withdrawing immediately, the U.S. will not only do what is best for the Vietnamese people, but for the American people also.

Recently many "peace" candidates including McCarthy, Rockefeller and Kennedy have endorsed various negotiated settlements. Our government has decided to try for a negotiated settlement because we have failed to achieve a military victory. There is nothing inherently wrong with negotiations, rather the participants can make them wrong and whenever the U.S. has a role in determining the future of Vietnam, whether one calls it exploratory talks, negotiations or whatever, it is wrong. We have no basis to negotiate from.

Do we negotiate on the basis that billions have been spent in Vietnam and that many thousands of American lives have been lost, or do we claim the basis lies in the fact that a dictatorial government, based in Saigon, with no support from the Vietnamese people invited us into the country? Neither of these is valid as a basis for our participation in negotiations. By rejecting the American leaders responsible for Vietnam and making sure that there are no future Vietnams, the American people can show that at least they have learned something from the experience. Nothing can bring back the lives or money. The invitation and support of south Vietnamese governments, past and present, is meaningless because they represent only the government officials and a few civilians who are profiting from the war. Since we had no justifiable cause for becoming involved in the first place, and this is generally agreed upon, we certainly have no right to continue our involvement by talking instead of fighting, or talking while fighting.

By including diplomatic efforts in their tactical plan, the U.S. government not only protects its imperialist position in Asia, but it also protects its position at home. All candidates supporting negotiations contribute to preserving the status quo. It is expedient to call for negotiations because it helps keep the opposition within the two party system. The peace movement is growing fast and the only way to prevent it from becoming a force outside the two party system is to toss it palliatives like negotiation and "peace" candiates. The PFM rejects both of these. We are a permanent third party and will not be co-opted by the Republicans and Democrats.


# Fight & Rent & Tax Control

The Peace and Freedom Party is part of a broad based coalition of community and church groups supporting th Campaign for Rent and Tax Control.

The Rent Control and Tax Relief charter ammendment calls for the election of neighborhood boards to inspect all housing and set a fair rent depending on the condition and size of the place. As well, no tenant would pay more than 20% of his net monthly income in rent. The ammendment gives tax breaks to home and small property owners as an incentive to make improvements. An accompanying statement of policy limits the assessment on homeowners and small property owners to no more than 10%. It places the burden of taxes on those corporations which make over a million dollars annually, to insure that revenue for needed city services will not be reduced.

Peace and Freedom supports this petition for the following reasons:
..... This campaign is an effective way to oppose the war im Vietnam. It challenges the tax structure which supports that war by attacking the very corporations in San Francisco which direct and profit from foreign policy while making us pay the bill. Only a strong local movement can divert federal priorities away from military expenditures and into much needed domestic programs. We can not depend on one elected official to make necessary basic changes for us.
..... Peace and Freedom sees this campaign as an important step in establishing a truly democratic institution. It allows the people to fight for control of a major necessity in their lives through the neighborhoos boards.

Peace and Freedom offers this as a concrete program to support the struggle of minority people and fight racism. The neighborhood boards are empowered to take immediate action on all cases of discrimination in the housing market. As well, these boards are easily accessable to all residents. We feel that the best way to oppose racism is to build a strong movement in both the white and minority communities around a common economic need. A coalition of renters, homeowners, and small property owners from all communities must unite to oppose the banks and real estate interests who now control the housing in San Francisco



The Peace and Freedom program For a Free Muni:

#### The Muni, Taxes & liberal Democrats

The San tFrancisco Public Utilities Commission and the Board of Supervisors are planning to increase bus, trolley and cable car fares. They estimate that this will bring in money, while cutting down the number of people riding the Muni by at least 15%.

Working people are forced to foot the bill on every level for government and business projects, be it the war in Vietnam, beautifing Market Street, or public transportation.

Nickle and dime increases appear to be small on the surface, but for anyone who rides the bus to work, for a fimily with 2 or 3 kids, a family on welfare or on a fixed income, these nickes and dimes hurt badly. For those already isolated in the ghettoes, this fare hike means decreased mobility and increased isolation.

The proposed increase actually constitutes a tax on those of us who can least afford it. And it is typical of Democrat and Republican solutions to financial problems. Rather than taxing those banks and multi-million dollar corporations who benefit from better transportation and who just had their taxes slashed by AB 80, their solution is to raise our taxes.

The Democratic Party has consistently supported these tax increases if not directly initiated them-showing that they represent the big financial interests and not the interests of the people. Even those "liberals who support the concept of a "free Munisystem call for another tax on all citizens to pay for it.

The Peace and Freedom Party opposes this fare increase and is currently fighting against it. In fact, we feel that the Muni system should be free. We think that the funds for the Muni should come from those .businesses and banks who can WELL AFFORD IT. It is they who profit from public transportation which brings their customers and employees to them, and thereby increases the value of their property. We demand that the Board of Supervisors institute a tax on these S.F. businesses to finance Muni.

Peace and Freedom Party demands a break from this policy of ever increasing taxes on working people, as Peace and Freedom represents a break from the two party system. We are not relying on a candidate as a panacea for local and national problems. The are instead organizing within our communities on a day to day basis. It is only through such independent political actions that we can bring about meaningful changes in our society.

#### SElf-defense on trial in Oakland FREE HUEY P. NEWTON NOW!

Huey P. Newton, the Black Panther Party Minister of Defense, is on trial for his life. He is charged with the murder of an Oakland policeman. We conclude, knowing Huey Newton and the cops, that if indeed, Huey shot a cop, he did so in self-defense and was forced into the confrontation.

The attack on Huey Newton is intended to kill the revolutionary potential of the Panther movement by killing its leadership. Newton and the Panthers are being attacked because they raised as the main organising demand, the right of black people to defend themselves against oppression by any means necessary, including arms.

#### WHO IS HUEY NEWTON?

In 1966, Newton and Bobby Seale founded the Black Panther Party. They began organizing around the right of self-defense, and developed a 10-point program that calls for full employment, decent housing, education clothing, an end to police oppression and the freeing of all black prisoners. The Panthers began to tell people they did not have to accept brutalization from the cops; they had the right to armed self-defense.

Huey taught this by example. The Panthers began patrolling their community to protect the people from police harrassment. They carried legal weapons, and when they saw the cops stopping a black person, they would get out of their cars, stand a legal distance away, and inform the individual of his rights.

This example of black people prepared to defend themselves was contagious. The Panthers won support among the black population and grew in membership. As the Panthers grew the cops escalated their attacks on the Party itself, and particularly against the leaders.

#### OCTOBER 28

On this day at 3:30AM the police claim they stopped Newton for a regular traffic offense, and this resulted in the shooting of Newton and the two cops. But there is no doubt that the cops were up to more than traffic duty at 3:30AM. At that time, the Oakland police department had distributed lists of the license numbers of Panther cars, including the car Newton was driving. They had pictures of Newton and the Panther leaders on police station wells. The pattern of police hunting-down Panthers has been repeated throughout the Bay Area.

#### FREE HUEY!

Huey Newton is being persecuted for his political belief that people have the right to defend themselves against the repressive arm of the state. He is actually being tried for demanding the complete liberation of black people. It is impossible for the same system which oppresses the black people to give one of their leaders a fair trial; they cannot try the real issue: it is not murder, but black liberation from oppression. Only mass political pressure -- in the streets -- can try that issue and free Huey.

All people, black and white, who come to Newton's defense are defending themselves. We must make it clear that black and white people have the same needs, the same enemies, are in fact allies, and will not be split by the tactic of racism.

# AFTER CHICAGO

The symbols of the Democratic Party are the billy club and the can of Mace. Its face is a composite of Hubert Humphrey, Mayor Daley, and Lyndon B. Johnson. Its policies are an affirmation of the criminal Vietnam war and of bloody repression directed against Black people, students, and all of those who would demonstrate their opposition to the course of American society.

After Chicago no one can doubt this.

New Politics? A change in American society? A meaningful policy for ending the Vietnam War? Whatever hopes some may have pinned on the candidacy of Eugene McCarthy--illusory hopes in our opinion--today it must be clear that the Democratic Party at its very heart represents the Establishment--just as in a different way does the Republican Party. Beatings, bloody heads, mace, "Gestapo tactics", "racism", "police state atmosphere"--the words are those of respectable Democrats--these describe the Democratic Party. These are the Democratic Party. No one who wishes to rebuild American society, to end poverty, exploitation, injustice--to support Black liberation and end the war--no one who wants these things can remain in the Democratic Party today.

After Chicago no one can doubt this.

Is it necessary to grind one's teeth in helpless rage, or to prepare (as McCarthy himself is doing), however reluctantly, to support Hubert Humphrey, out of fear for Richard Nixon? We already know the answer---from experience. People gritted their teeth and supported Johnson in 1964.

The lesson of Chicago, the lesson of the last four horrible years of war, of vicious repression of Black rebellion, is that the Democratic Party is not and cannot be the instrument of basic change which America requires. It cannot be changed from within. What was necessary in 1964 is a thousand times more necessary in 1968: not support for so-called lesser evils, but beginning the hard and perilous task of building a movement of opposition. A movement of such magnitude, drawing upon all of those committed to ending the war and for support to the struggle of the Black people to end their oppression by White America -- a movement of such unwavering opposition to the Democratic Party and all of its tendencies that even the rotten old politicians cannot ignore it but must attempt to appease and even make concessions to it. This movement must take place in the streets, outside of the normal boundaries of the political system (and with Nixon or Humphrey the next President it is guaranteed it will take place outside of the old structure) and it must also take on an organized political form. A one-shot presidential campaign which leaves no movement or organization behind is not enough.

After four years of war can anyone doubt this?

The Peace and Freedom Party is a start toward such a movement and such a political break with the Democratic Party. But, it must be stressed, it is only a start. Without the support of those who find themselves convinced that a new beginning must be made <u>now</u> it it is to be made at all, there is no hope-for exerting pressure on the existing parties, for beginning to reconstruct American society. The Peace and Freedom Party exists to be the instrument of that movement—it stands ready and open to those who do want to build such a movement. It stands for opposition to the thugs and political gangsters who

are the Democratic Party; it stands for immediate unilateral withdrawal from Vietnam; it stands for Black liberation and for the end of poverty and oppression. Its candidate Eldridge Cleaver will be a means of demonstrating opposition to Humphrey and Nixon in November. The Peace and Freedom Party invites all those who now recognize the need for such a movement, who see the need for a decisive break with the corrupt and criminal policies of the Democratic Party to join with it in making a new American society—one of real Peace and genuine Freedom.
