PROPOSED POLICY STATEMENT, STRUCTURE, AND ISSUES OF SAN FRANCISCO PEACE AND FREEDOM

PROPOSED POLICY STATEMENT

The Peace and Freedom Party supports the right of selfdetermination for all peoples of the world. Therefore, we oppose United States economic, political and military imperialism, which denies them this right.

Specifically, we support the just struggle of the Vietnamese people, including the National Liberation Front, for their own liberation, and demand the immediate withdrawal of all United States and allied troops from Vietnam. The American government has no legitimate interests to negotiate there.

Peace and Freedom allies itself with the struggles for liberation of the oppressed peoples within the United States---the black, poor white, Spanish-speaking and American Indian peoples.

Specifically, we support community control and the right of armed self-defense as steps forward on the road to liberation for the oppressed peoples in America. We support the 10 point program of the Black Panther Party.

Peace and Freedom views the struggles of the American working people--organized, unorganized and unemployed---against exploitation and for an economic system based on social ownership of the farms and factories, workers' control of the work place, democratic planning of the economy, and production to satisfy human needs rather than the greed for corporate profit, as decisive in the fight for progressive social change.

Therefore, we support the struggles of rank-and-file workers to gain control of their unions; the fight to end racism in the unions; the right of public employees to organize and to strike; and the organizing of the unorganized, particularly migrant farm workers who live and work under slave conditions.

Peace and Freedom supports the struggle of women for economic and social equality.

Peace and Freedom recognizes that the Selective Service System is being used as a club against the most vital and potentially radical force in this country; namely, the youth. At the same time, it supplies unwilling manpower to carry out our militaristic and repressive foreign policy.

We therefore insist on an end to the Selective Service System and fully advocate and support people's refusal to serve in the armed forces, the turning in and burning of draft cards, and the destruction of this social institution by whatever means necessary.

We also support the right of free speech for American servicemen and their efforts to organize themselves in their own interests.

Peace and Freedom supports the struggles of students to gain control over the educational institutions which directly affect their lives, and we particularly support the struggle of high school

students to share the responsibility for the decisions which directly affect their futures as educated citizens.

In order to achieve these ends we must create our own political institutions, independent of the Establishment-controlled parties and institutions. We must commit ourselves to these struggles not only thru electoral means, but also thru direct action, resistance and other forms of non-electoral activity.

We recognize that the Peace and Freedom program will not be met until the people organize to demand it, and success in building a people's movement depends on their day-to-day battles around local demands.

Peace and Freedom will therefore initiate and support community struggles around jobs, housing, schools, police control, labor demands, taxes, heatlh, public transit, prisons, corporate exploitation, the draft, and opposition to guncontrol---and must unite these issues by showing how they are part of a larger struggle to transform American society and return democratic control to the community.

I) NEIGHBORHOOD & SPECIAL INTEREST GROUPS (NHG/SIG) -

A - Voting in NHG/SIG is open to all P&F registrants and disenfranchised persons properly registered with that specific NHG/SIG.

Each NHG/SIG must maintain an up to date record of all persons registered within that group. These records must be cross checked with records at Colton Street.

In order to effect a transfer from one NHG/SIG to another NHG/SIG it is the responsibility of each transferring member to notify both NHG/SIG. No P&F member may be registered in more than one NHG or SIG.

B - Fifteen people attending meetings make up a NHG or SIG. Each NHG or SIG will send two delegates to the County Council (CC).

Qualification as a NHG/SIG is to be based upon average attendance of P&F members at the last four regularly scheduled meetings. New groups shall be allowed to send two delegates to the CC for the first six weeks during organization.

C - Voting on proposals in NHG/SIG will be limited to those P&F members participating in the NHG/SIG at which the vote is tallied.

D - As soon as possible after each meeting each NHG/SIG will send to the County Office via their delegates a list of:

- 1) Vote Tabulations
- 2) New Proposals
- 3) Meeting Sign-in Sheets

II) COUNTY COUNCIL (CC) -

- A The CC will have the power to do only that which the NHG/SIG have expressly authorized.
- B Delegates to the CC will:
 Give tallies of votes taken on proposals previously sent to NHG/SIG.

They will submit new proposals from NHG/SIG to be taken back and voted on by all NHG/SIG.

They will hear and discuss issues and/or problems brought forward by various committees.

They will hear cross pollenization of ideas between NHG/SIG and hold discussion on those ideas.

C - Two-thirds $(^2/3)$ of the NHG/SIG must have submitted tallies on a proposal before it can become P&F policy.

All votes to be taken on proposals submitted to NHG/SIG shall be tallied at the CC two weeks after the CC meeting at which the proposal has been submitted.

D - Delegates elected to the CC are to have the responsibility of obtaining a sufficient number of copies of new proposals from CC meeting to supply each member of his NUG/SIG attending meetings.

Delegates shall also be responsible to bring new proposals to the County Office at least two (2) hours before the CC meeting.

III) COUNTY COMMITTEES -

A - Emergency Committee:

Definition - A five man committee whose purpose is to decide upon the need to call an Emergency Meeting and to call such a meeting. A vote of the simple majority of the committee will suffice to call a mass meeting. The mass meeting will only deal with the specific emergency for which it has been called.

The Emergency Secretary of each NHG/SIG will be notified at the time they are called of the time, place and subject of the mass meeting, the Emergency Secretaries are in turn obligated to notify their NHG/SIG of the above.

Selection - The delegates to the CC will nominate persons to sit on the Emergency Committee. Each nominee must be accepted by a majority of the CC delegates present. The list of nominees will then be sent to NHG/SIG who will vote upon the nominees. The votes will be tallied in the regular manner and the five receiving the most votes will sit on the Emergency Committee, subject to recall by popular vote.

B - Working Committees:

Any functioning administrative or special subject committee will be called a Working Committee.

Working Committees will have the same privilege as NHG/SIG to submit pro-

posals to the CC for vote in NHG/SIG.

Every member of every committee must be a registered member of a NHG/SIG. The chairman of each committee shall be elected by a simple majority votes of the committee members, for periods to be specified by the committee members, subject to recall by the committee.

Chairman of respective committees shall report to the CC once a month or

as directed by the CC.

C - Co-Ordinating Committee:
The Co-ordinating committee will be comprised of the chairman of each working committee.

D - Formation of New Committees:

The CC shall have the authority, by vote of the simplw majority, to establish new committees as necessary. Committees will be Ad Hoc until ratification or rejection by NHG/SIG.

IV) PROPOSALS -

A - Emergency proposals must be submitted to the Emergency Committee.

B - Proposals which have been voted down in the makers NHG/SIG may be brought before the CC by the maker and submitted under New Business for consideration by all other NHG/SIG.

V) FINANCES -

- A A Finance Committee will be established. The committee to be constituted of ore elected representative from each NHG/SIG and one elected representative from each County Working Committee. Only those representatives from the NHG/SIG shall have a vote in the Finance Committee.
- B The secretary and bookkeeper shall sit on the Finance Committee as non voting, members.

C - The Finance Committee is to receive and review budgets, and allocate funds.

Publicity COMMITTEE

Wants to know the boundaries of each neighborhood group, telephone contacts, dates and places of meetings. Publicity Committee is putting out a newsletter and other literature which they hope to get out to the neighborhood groups this weekend. They urge all neighborhood groups to send a member of their group to sit on the Publicity Committee. It is this committee's wish to work in close association with the neighborhood groups which can only be done effectively if a member of that group is on the committee.

PLATFORM COMMITTEE

To make sure everyone is aware that if they want proposals to be considered for the Convention they must be submitted to this Committee. Mike Rubin will take the responsibility to see that each consideration is brought up to the State Platform Committee. All resolutions will then be presented at the State Convention.

DIRECT ACTION COMMITTEE

Intend to carry out via direct action and necessary activities decided upon by the County Council. This is not a policy-making body. This Committee will aid in planning demonstrations, rallys, etc. Anyone interested in the committee should have experience in such direct confrontation or be willing to enter into such direct confrontation.

14 people at meeting. Voted on legalization of Marijuana. Voted on statement that they would like the Party to back slogan "Fair trial for Huey Newton as an individual" ---- PASSED 10-2-2 Voted for one delegate for two people (registrants) from the neighborhood groups to the County Council.

UPPER WESTERN ADDITION Ralph Escobar

Voted for \$50 to be given to Finance Committe.

MINUTES OF 1st COUNTY COUNCIL MEETING CONTINUED:

functions. Such functions could include planning demonstrations, rallies and other such direct confrontations. It should be noted that anyone interested in working on the committee should have experience of such direct confrontations or be willing

to participate in such direct confrontations.

LABOR CAUCUS John Moran

37 people attended meeting.

Voted on "Resolution in support of the Newspaper strikers". Said resolution has been distributed to all representatives of neighborhood groups attending the County Council Meeting. PASSED 37-0

The Labor Caucus would like neighborhood representatives in this group.

Stated that people from all forms of arts active in group. No proposals.

NOE VALLEY Cathy Dahlgren

Statement by Joey Macs, a member of the Committee:

The extent and nature of fraud on the part of welfare recipients will be investigated by the State Social Welfare Board on February 16 in San Francisco. The Board, dominated by Reagan-appointees, has already held three hearings in other counties of California, and intends to go on to Los Angeles on March 1st.

what is Reagan's purpose, what does he gain by attacking the poor? First, to make personal political use-during a Presidential election year-of an already emotional issue involving a helpless section of American society. Second, to pass re ressive welfare legislation based on the record from biased and unpublicized hearings.

Why do welfare recipients oppose these hearings? Thy should everyone in

the community oppose thom, also?

We are being attacked for living as we are forced to live. We need training and rehabilitation programs, child-care centers and JOBS in order to get off Welfare. We need an entirely new approach to the administration of social services. Not punitive measures but programs which give us our human rights.

We are forced to live in substandard housing, drive bargains to feed our children and somehow subsist on a monthly grant almost thirty per-cent below the official poverty line income. Life for a welfare recipient is a constant battle for dignity.

A welfare system that does this is fraudulent. A society that allows such a system is destructive.

A community that refuses to see the relationship between welfare issues and its own problems is apathetic.

Almost one-sixth of our population is at or below the government recognized poverty line. The Peace & Freedom Movement cannot be of great relevance today if it does not include within its political platform a demand for a restructuring the welfare system.

SUBMITTED TO EMERGENCY MEETING OF COUNTY COUNCIL, 55 COLTON STREET, BY HAIGHT-ASHBURY INDEPENDENT CAUCUS, MONDAY FEBRUARY 19, 1968.

The Haight-Ashbury Independent Caucus urges this emergency meeting of the Peace And Freedom Party to strongly castigate the brutal police reaction to the imprompts street gathering of Sunday February 18, 1968. The Peace And Freedom Party should not necessarily condone the action of those who were dancing and blocking traffic in the central section of Haight Street. But we are vehement in our outrage at the indignities and obscenities directed at innocent bystanders and at those who by force of fate were caught in the police cordon. Defenseless teenage girls were bloodied and beaten by armed policemen. and this we shall not stand for.

Specifically, we deplore:

- L) The initiation of anti-riot tactics, when a questionable state of riot exists.
- 2) Unnecessary use of riot batons with intent to cause bodily harm.
- 3) Anti-riot tactics that trap individuals attempting to disperse.
- 4) Indiscriminate use of tear gas and Mace.

And we demand that a review board be initiated to deal with these insidious, premeditated, anti-riot--anti-human tactics. And with all cases of police brutality, mass..and individual. A leash must be provided for the police dog. For if we are to beget storm troopers, then a counterforce or counterweight must be provided for the safety of each individual. If this is not done the next step is a gun in every closet. An armed camp. We prefer the alternative. And propose that a civilian review board, open to the public, and similar in general composition to the one brought into being by Mayor Lindsay of New York..be put into immediate effect. We desire this check system as a simple protection for every living American. And we shall push for it's immediate birth in San Francisco. A leash must be provided for the pelice dog.

Haight-Ashbury February 19, 1963 proposed RESOLUTION ON POLICE (to be considered at SF--PFM Emergency Meeting on Police Monday, 6 PM, 19 February 1968)

1. That the San Francisco Peace & Freedom Movement condemn the police brutality which occurred in the Haight-Ashbury district on the afternoon of Sunday, Feb. 18th.

- 2. That SF-PFM call for creation of Civilian Police Review Boards in the various neighborhoods, composed of citizens elected by their neighbors, who will supervise and restrain their local police.
- 3.. That the SF-PFM chall establish a new working committee, the Committee On Police Surveillance (COPS), which wak will be authorized to work with Citizens Alert, work against police brutality and police misconduction campaign be for municipal ordinances creating Civilian Police Review Boards; and to serve as an unofficial agency of surveillance of the police, including (if necessary) as the sponsor of "cop-watching patrols" which could be equipped with cameras and tape-recorders and walkie-talkies; etc.
 - A. That, since traffic congestion on Haight Street has repeatedly been used as an excuse for police "military actions" against hippies and other persons in the Haight-Ashbury, we wish to declare that human rights are far more important than automobile traffic; and that includes the right of a citizen to stroll, lounge, or loiter on the streets, sidewalks, and parks; and that if autos and people cannot co-exist on Haight Street (as the police claimed Sunday), then it is the autos which must give way, leaving Haight Street as a pedestrian mall.

(Note: We are not here saying that automobile traffic must be excluded; merely that it must no longer be used as an excuse for dispersing peaceful crowds of pedestrians.)
