COUNTY COUNCIL MEETING OF APRIL 1, 1968

. Meeting called to order at 8:20pm. Chairman: John Meuser.

COMMITTEE REPORTS -

Fund Raising Committee reported on the breakdown of their expenditures. Breakdown available at Colton Street and has also been distributed to NHG/SIG boxes.

There was a loss of \$285.74 on the dance of March 22. Most benefits have lost money because of lack of participation on the part of P&F members.

Tickets are now available for the April 10 Fillmore Auditorium Benefit.

Posters will jow be distributed only to those people who will hang them for public advertising. Posters will no longer be used for purposes of interior decorating in the homes of P&F members.

A letter will be sent in the near future asking, again, for all P&F members to contribute \$1.00 a month (\$12,00 a year) to help with the operation of the party. Discussion of the selling of the P&F mailing list.

Office Committee - A question has been raised which we have got to answer immediate-

ly: Does SF P&FM need the county office?

There are two general arguments which we'll out line here. The first says that the county office may be necessary but it is extremely chaotic, and invariably gives Party members who come there to work a terribly oppressed feeling. Almost everybody who goes there to work is turned off, and few in fact ever return. Moreover most

of the present staff are burned out and they're quitting.

The second argues that there are concrete needs which the county office fulfills for the 39 NHG in the SF movement. In specific the office provides a central coordination for information about the Party/Movement, both to party members and to interested persons. In specific the office provides printing facilities, central mailing facilities and central co-ordination on action through the use of the phones. And it provides a central place for both meetings and work. Nevertheless the place is not a place to write home to mother about, and it is certainly not a place to bring your mother to. And it is goddamned inefficient. The second argument has however an alternative to abolishing the office. That is that the inefficiency and the crumminess of the office and the way it is run and appears will only be resolved when the hundreds of active party members feel the need to make that office run to meet their immediate program needs that develop in their neighborhoods and in the larger community and campaign actions. But, screams the terribly frustrated party member, we don't have any goddamned such programs or campaigns, such as local actions to get reforms in the school down the block where my kid goes, and to get rent control and lower small homeowner taxes in San Francisco, and to get the cops out of our communities, and to get more day care centers throughout ou neighborhood. And so what the hell real needs do we have now that I need that damn hippie crazy office for, that's full of crazys and hippie indian-fakers. And hippies and crazys and more kooks, and the full time heavies.

The answer, says argument two, is none. And so the conclusion is that we need a program of real concrete actions around which to organize. Not so we can keep the office open, but so we can organize. But in the meantime we still need an office, which can fulfill some of the more essential central functions which were outlined above. And the office costs money, so untill we all feel the real need to work and make that office meet our political and action needs as we begin work on our programs and campaigns, we should put up enough money to keep the office doing the

things we in fact need.

It was suggested that the NHG/SIG need more central direction, particularly in re-

gards to political issues.

Publicity Committee suggests that there are aspects of the Pub. Comm. that can be handled by the NHG/SIG. The Pub. Comm. could then act as a super-structure to co-

ordinate all those interested persons and/or groups.

Proposals Committee asks that the NHG/SIG ty, as soon as possible, to get out the votes on all pertainant proposals. Now that we have a structure it will be possible to actually make policy for the SF P&FM. All that is needed is a quorum of 2/3 of the NHG/SIG for vote tally.

PROPOSAL # 207 by the Bernal Heights group of SFPFM 4/1/68 this is our 2/16 proposal which was lost in the depths of county structural turmoil.

- Whereas: The United States has actively enagaged in the suppression of a nationalist movement in Vietnam by supporting the French colonists prior to the Geneva Convention of 1954.
- Whereas: The SEATO treaties cited by the United States as our commitment to stop communist aggression in Asia were entered into when it became apparent that the French were losing their war, and just several months before the French didi lose it. That none of the many regimes of South Vietnam have ever been signatory to the SEATO treaties. The real intent of the SEATO treaty is clearly to maintain a Western power foothold in Asia.
- Whereas: the agreements of the Geneva Convention, specifically the agreements to a free nationwide election within two years, were never honored by the United States. It was apparent that the overwhelming majority of the Vietnamese population would vote for the national hero, Ho Chi Minh, and the country would be reunified. The United States has broken the international agreements of Nuremberg and the United Nations Charter as they would apply to Vietnam.
- Whereas: The formation and rise of the National Liberation Front was made up of the indigenous population of the south and formed to resist the increasing pppression of an unpopular leader, Diem. The National Liberation Front is autonomous and is not controlled or directed by the Democratic Republic of Vietnam. The fact that there may be DRV troops in the south is irrelevant; it is their country.
- Whereas: The United States refusal to recognize the National Liberation Front and the continual citing of the Hanoi leaders as the responsible agents has resulted in unspeakable acts of genocide against the people of the South. The continual devastation and attempt to exterminate the people living in the Democratic Republic of Vietnam shows the desire of the United States to destroy a country and its people who hold different political beliefs. The illogical argument that by bombing some people on one side of an artificial boundary you can defeat and bring to the negotiating table the people on the other side of the artificial boundary shows that the United States is acting in bad faith. It is clear that there is nothing to negotiate. The United States is a foreign invader carrying on as aggressive war against the entire country of Vietnam.
- Whereas: The United States entered upon this action in bad faith to further her own political, economic, and military interests in Asia. It is not in the best interest of the people of Vietnam nor the People of the United States. The people of Vietnam have suffered horribly under the guidance of a few U.S. military commanders and industrial businessmen. The people of the U.S. suffer by paying exorbitant taxes to finance this war, by having their social services cut in half, and by losing family and friends in an unjust war.

Resolved that: THE ONLY POSSIBLE REMEDY IS IMMEDIATE, COMPLETE, AND UNCONDITIONAL WITHDRAWAL OF ALL U.S. FORCES, HER SO-CALLED ALLIES, AND ANY VESTIGES OF U.S. PRESENCE AND RESTITUTION FOR

DAMAGES AND WAR CRIMES

POLICY GUIDELINE STATEMENT FOR SFPFM ELECTORAL ACTIVITIES submitted by the Bernal Heights neighborhood group of SFPFM 4/1/68

The Peace and Freedom party is a distinct, permanent and independent political party, separate from any other political party; it sees the Democratic-Republican party as one of the institutions which bears major responsibility for the decadence of American society, as well as many others; it condemns compromise and participation in any form with the old parties and their morally bankrupt policies of racist imperialism; it condemns those who, acting in "good faith" or otherwise, perpetuate this corrupt system by participating within it.

The Peace and Freedom party exists to give focus and political expression to the Peace and Freedom movements. It relies on the energies of ordinary working men and women as well as students and intellectuals to accomplish it"s programs; it demands constant communication of the elected with the electors and constant confrontation with the institutions and administrations which concern people and which affect their daily lives.

The Peace and Freedom party accepts electoral action as valid only in a context which includes political organizing, political education, protest action, direct action, and other forms of non-electoral movement actions.

The success of the Peace and Freedom movement will be determined by the extent to which everybody is involved in effective political discussions. The development of continued interaction of all people on a daily basis regarding the issues which directly affect their lives, and the vehicle through which they can express their desires and acheive their goals is a major concern of the Peace and Freedom movements electoral activities.

The entire thrust of the SFPFM campaigns shall be directed towards building a large cohesive base of strength among the people which will permit significant action in the years to come, rather than just amassing a large number of "protest" votes in November.

The Peace and Freedom campaigns shall delineate the long term perspective of the Peace and Freedom movement.

RICHMOND #2

- 212. Any member of the Peace and Freedom Movement who is a registered voter in any other party be restricted from holding office or casting a vote in any community group, neighborhood group or special interest group of the Peace and Freedom Movement.
- 213. That in proposal # 196, the phrase "2 weeks" be ammended to read 4 weeks.
- 214. That the United States not participate in the Olympics if Scuth Africa is allowed to participate for the following reason:

 South Africa is a racist state and if we participate, we will be supporting a racist state.
- 215. That the Peace and Freedom Movement support the Negro athlete's boycott of the Olympics.

BERNAL HEIGHTS

- 216. That Paul Jacobs \$200 per week fee, plus expenses, for being P&F's Senatorial candidate be reduced to the level of fees (salary) paid to other local organizers, plus necessary expenses, and that this rate shall apply to any and all P&F candidates.
- 217. That propose 1 #200 re initiating a national conference to select a United States Pres. and V.P. candidate be tabled until May 6,1968

S.F. State

218. The San Francisco County Peace and Freedom Movement supports the demonstration at the draft board located at 100 McAllister scheduled for 3 o'clock on Friday, April 26. The demonstration has been called by San Francisco State Anti-Draft Union and will consist of an outside picket line and people entering the office at the draft board to exercise their legal right to file statements in their selective service system files.

Proposals Committee

MOTIVATION - There are obviously too many proposals coming out. No functioning neighborhood group can possibly expect to discuss and vote on all these proposals and still expect to carry on its most important functions, community organizing and neighborhood projects.

Meeting called to order 8:20pm. Chairman: Bruce Hartford

COMMITTEE REPORTS

Organizing reported on a pilot 'storefront' or gram for purposes of Community communications (i.e., a meeting place, place for distribution of literature campaign head-quarters). Tentatively to be tried in the Sunset or Fillmore areas. Financial support through the dues of community P&F members putting the project into operation. Internal Organizing is checking with NHG/SIG meetings to recruit committee members. Idea of committee is to find out whats happening in the NHG/SIG presentation of programs and projects helping organize around issues; to draw people in and to channel initiative; report trouble spots. Pointed out that not only the NHG/SIG are not functioning, but the committees are having the same problem with non-participation. We must get down to the hard job of recruiting and organizing. The Precinct Plan was formed with this p rpose in mind. The plan being that the NHG/SIG would, hopefully, use the Precinct Plan for organizing in their areas.

Program Implementation (formerly Direct Action) will be busy mainly with the 18 year-

old initiative, and Stop the Draft Week,

They have broken down into four sub-committees: Research and Education, Supply, Publicity, and Monitors (P&F security). Volunteer help is needed Contact EZ at 431-0384 Fund Raising reports approximately \$1,600 was made on the A pril 10 benefit at the Fillmore (an estimate of \$2-300 still out in NHG/SIG) and \$140 on Slow Dance on the Killing Ground'. After expenses of about \$500 and the repayment of our loan to the State, plus the payment of some of the more pressing bills we have approximately \$700 in the P&FM general fund account. There are, though, still bills outstanding to be paid.

Collection of dues has been voted on and passed by NHG/SIG. The NHG/SIG should make a concentrated effort to push the collection of dues, it is a necessity for the smoother operation of P&F that we try to keep out of debt.

Negotiations for the Avalon at \$240 for a May benefit.

Discussion of the mob of collecting the ousstanding pledges from the Convention.

Elections/Campaign reports that due to the general haraassment of the Black Panthers and their Campaign Headquarters by the Oakland Police, there are not too many Panthers left to devote time to campaigning. That the panthers will push the Write-In candidates in the Black Communities.

Suggestion that a letter writing campaign be lodged against Assemblyman Willie Brwwn Letters to request, strongly, that he directly involve himself in the case of Eldridge Cleaver. At this point he is not doing anything to help either Mr. Cleaver or his constituents.

Sub-committees will be set up by districts in order to implement campaigning procedures effectively. Volunteer workers will be needed. Contact John Meuser - 431-4365

Publicity - New chairman of the committee is Lee Yeager. Discussion of the purchase of components for a sound system...a printing press that is being donated to P&F and the possiblity of using it to publish a P&F Newspaper.

April 27th nobilization discussed. How can, or should, the P&FP/M participate. Points made: An opportunity to let people know what P&F is. By standing behind April 27th and

other activities that support the policies of P&F.

An organizing tool that can help build P&F.

That we should not put our fingers in too many pies.

The party/movement has a duty to participate in and constructively help to form, any activity which has such political overtones that are also held by the P&FP/M.

That in order to show the people of SF area how we operate on a grass roots level, each NHG/SIG should make an effort to participate perhaps marching under the banner of that particular NHG or SIG.

MOTION That P&F, in conjunction with our endorsement of Stop Draft Week, should participate in the April 27th March. That the Program Implementation Committee participate in the Steering Committee meetings of the Stop the Draft Week and relay information and instructions to the NHG/SIG.

PASSED

State Steering Committee: reported on discussion of the aborted Vacaville Car Caravan.
Partly due to the cost that went into the mobilization for the Memorial and Caravan

the State Office is in debt for \$4,500.

A national Organizer has been sent to New York, Michigan, and Wisconsin for the purposes of discussing the ways, if any, the third parties are in policy agreement. A drive to be launched to get, in as many states as possible where registration requirements are not severe, P&FP/M on the ballot.

If enough agreement is reached it has been suggested that we may hold a National Convention for the purpose of nominations a Presidential and a Vice-Presidential candidate. At this time a National Convention with 12 to 15 states participating looks hopeful.

Discussion of a possible Summer Project - getting college students to go back to their home States to organize and build P&F party/movements, and to build communication

A coalition with groups trying to put third parties on the Ballot is imparative - when those parties follow the California P&F policies. It is essential that California take the initiative in order to build our own party and not get lost in the shuffle.

A P&F Benefit for the Campaign Committee will be held at Donovans Reef featuring the Cleveland Wrecking Company on April 27 at 7pm.

A picket at DiMaggio's restaurant on Fishermans Wharfwill take place on April 20 at 6pm to demand that Mr. DiMaggio and his fellow draft board members resign from the draft board because they have no right to decide whether or not we should fight their war against the people of Vietnam.

April 26th at 3pm will be a Mass Demonstration at the San Francisco Draft Board at 100 McAllister Street.

The Labor Committee will meet Sunday at Colton St. at lpm.

SPEAKER: PAUL JACOBS - Candidate for US Senate. Points made:

Feels that 3rd Parties which do not follow the lines of the California P&F are not a serious threat because of loose coalition within them.

In New York the situation is ripe but complicated by internal battles. They do have a functioning office with functioning staff. There is much interest on the East Coast in the activities of the California P&FP/M.

Mr Jacobs urges that Union members join and actively participate in P&F. Feels that the bureaucratic operation of most Trade Unions is a detrement to the effectiveness of the unions.

At times suggests that actions against the Unions are in order when the Union leader ship rules against the best interest of the rank and file Members.

That the function of the Labor Caucus should be to spread P&F through the Unions so that P&F can operate within them.

Believes in the overthrowing of the Capitalistic System but does not have any rigid notions as to what type of socialism operation would replace it. That the working class does not automatically represent the best values of the society as a whole.

Feels that the Foriegn Policy of the USA is wrong in its attitude toward the Socialis tic World and Movements of National Liberation.

Does not believe in violence for the sake of violence, but recognizes that rarely does social change take place without it. That by understanding the nature of change violence can be minimized. That Social Change is certainly a necessity.

Does not know the origin of the rumors as to his alleged involvement in the CIA.

Does feel that it was wrong that the CIO kicked out all Unions either pro-communist
or seemingly pro-communist. At the time did feel that the ILWU had several policies
not in the interests of the rank and file members...felt they were not radical enough.

That he should not have participated the way he did, but should have fought on a
different level

At the time he was booted out of the CIO he was in continual conflict with them because of his attacks on the FBI, McCarthism, and some of the CIO policies. As a matter of record the government is very anti-Paul Jacobs.

Concrete suggestions for the Unions to use in combating racisim include pointing out to the Trade Unions that they do have a responsibility for stopping racism within the Union. And that Apprentice Programs in the Trade Unions should be open to Black as well as Brown workers.

What had been happening in American Society in the 30's tended to re-radicalize him. He is in P&F to transform the society in which we live.

He, along with others, is being sued for libel by Harry Bridges. The charge stems from an incident in which the promotion of 62 members of the ILWU was not allowed. 61 of the men were negros. That to which Paul Jacobs addresses himself is that the men were kicked off their jobs without a trial. In an Educational Leaftet there is a statement in which Harry Bridges feels he is maligned.

Because of his action the ILWU stands against Mr. Jacobs...with the possible except: of I cal #10 which is predominantly black.

That the USA faces a second civil war because of the inequality rampant throughout the establishment. That the real enemy of both the Blank and White is the establishment (the government). That all institutions of the American government are basically racist. In the beginning racism started for the reason that the whites wanted and needed the labor and/or property of the minorities. Has great concern for the future when white racists could conceivably turn violently against the Black Liberation Movement. To solve the problem radical surgery must be performed to transform the society to root out the sources of racism we must realize how deeply imbedded racism is in our life. We cannot escape our environment, we must understand that environment and work to change it.

That he was not an author of the poverty program. S. Shriver asked Mr. Jacobs to attend a meeting for the purpose of educating Mr. Shriver on poverty and its causes. It soon became obvious that the Poverty Program was a total farce. He is now an avid critic of the program.

That he will be governed exclusively by the dictates of the P&FP/M. That he is not a personality running for the US Senate, but is a representative of the P&FP/M.

Will encourage participation of NHG/SIG throughout the state. The function being to raise issues, stimulate debate, and organize a vehicle geared for National Organizing, on the assumption that P&F is the only party which can change the establishment.

That we must use this campaign to build the movement. We may lose the elections but we will have an ongoing organization.

Suggestion that an ongoing discussion and education group of the P&FP/M be set up. To raise for discussion and to then knock down certain fantasies of the middle class morality (i.e., Marijuana issue).

Will be debating Mr. McCarthy at San Fernando State College in the near future. Mr. Jacobs will return to CC on April 22 for further discussion with the delegates.

MOTIVATION FOR PROPOSALS TO AMEND SFPF COUNTY BY-LAWS, as submitted by Fillmore Group to County Council 4/15/68

220: This change adds the requirement that delegates to the CC be chosen by election. Creates added grass-roots representation by ensuring that all PF members have chance to participate in delegate selection and control. Increases accountability of delegates. Allows recall at any time.

221: An addition to CC powers. Allows CC to require vote from the NHG/SIG's on urgent matters. 2/3 rule discourages abuse. Increases grass-roots participation in emergency decisions.

222: An addition to CC powers. The CC may, by 2/3 vote, decide to work with and for a Working Committee on a given question. 2/3 rule discourages abuse.

223: Replaces the present proposal quorum, based on number of groups voting, with a quorum based on number of votes cast. Sets this quorum at a simple majority (8) of the minimum definition of NHG/SIG (15) multiplied by the number of groups in existence. Permits us to come to policy determination more easily but retains quorum safeguard.

224: Eliminates present requirement that NHG/SIG's must vote on candidates for the Emergency Committee and gives this responsibility to the CC. Present system cumbersome, incapable of quick response, and is in fact not being used.

225: Eliminates present requirement that the formation of new Working Committees by the CC must be ratified by the NHG/SIG's. Present requirement is cumbersome, does not exercise effective control, and is in fact not being used.

226: The section proposed for elimination deals with the formation of a Finance Committee and gives it the power to review budgets and allocate funds. In actuality this is being done by the Co-Ordinating Committee, and the proposed change in III)C formalizes present practice. (We do have a Fundraising Committee which acts as a Working Committee and needs no formal By-Law legitimization.) Under present state of organization the Co-ordinating Committee is the only body in a position to act as Finance Committee.

The proposed III)C also allows a Working Committee to designate someone other than its chairman to sit on the Co-Ordinating Committee if it so desires; and allows Co-Ordinating Committee to expand itself as necessary. Both practices have been found to be frequently necessary, and this change also simply formalizes present practice.

NEW BUSINESS

List of Proposals submitted to NHG/SIG re: changes in the County Structure (By-Laws). They have been distributed to NHG/SIG boxes.

A Finance Committee has not yet been established as provided for in the present County Structure. Suggestion that it be discussed at the next CC meeting.

OLD BUSINESS

Proposal inadvertantly omitted from CC meeting minutes of April 8 1968... for purposes of discussion:

That the present CC Emergency Committee is not functioning as an efficient ongoing representation of the NHG SIG. The information (propaganda) which has come out of the special emergencies which have been called has not been representative o the membership; i.e., Emergency Committees called to issue statements representing the entire County P&F?/M. Therefor it is recommended that the CC elect an ongoing representative group from its body, to handle all propaganda and that a new Emergency Committee be formed.

PROPOSALS TO AMEND SFPF COUNTY BY-LAWS, submitted to County Council 4/15/68 by Fillmore Group (by vote of 13-0, 1 abstention.)

PROPOSAL 220: Change the second sentence of By-Law sec I)B to read:

"Each NHG/SIG will send two elected delegates to the County Council (CC) who will serve until replaced by election within the NHG/SIG."

PROPOCAL 221: Add to By-Law sec II)A:

"The CC may, by 2/3 vote, designate a preposal as an Emergency Proposal, which designation shall mean that the NHG/SIG's are required to vote on the proposal at their next scheduled meetings or at emergency meetings which may be called by the NHG/SIG's at their option."

PROPOSAL 222: Add to By-Law sec II)A:

"The CC may, by 2/3 vote, constitute itself as a committee of the whole on any question reported by a County Working Committee, in which case the CC's determination of the question shall be that 'Committee's determination of the question."

PROPOSAL 223: Eliminate the first sentence of By-Law sec II) and insert in its place the following:

"A total number of votes equal to eight (8) times the number of qualified NHG/SIG's shall have been tallied on a proposal before it can become SF P&F pelicy."

PROPOSAL 224: Eliminate the last paragraph of By-Law sec III) and insert in its place the following:

"Selection - The delegates to the CC will elect five (5) persons to sit on the Emergency Committee subject to recall and replacement at any time."

PROPOSAL 225: Eliminate the last sentence of By-Law sec III)D.

PROPOSAL 226: Eliminate By-Law sec <u>V)</u> ("FINANCES"). Also elminate sec <u>III)C</u> and insert in its place the fellowing:

"o-Ordinating Committee:
The Co-Ordinating Committee will be comprised of the chairman or a designated representative of each County Working Committee, plus additional members as determined by the Co-Ordinating Committee. The Co-Ordinating Committee shall also receive and review budgets, and allocate funds."

PROPOSALS COMMITTEE CLERICAL PROCEDURE

All motions submitted to the county council and not tabulated shall be termed "proposals" and numbered as such, as is the current practice.

All proposals that have been tabulated by this committee and have passed according to the current by-law qualifications shall be termed "resolutions" and re-numbered as such (R1, R2, R3, etc.).

Additionally, the resolutions shall be catagorized according to their content and/or intentions such as: (B) By-laws amendments (procedure); (P) Policy (what we stand for); (A) Action programs (doing something!) (C) Critical reviews and grievances (to register intra-organizational complaints); (O) Organizational matters (Principles involved in organizing proceedure); Emergency Mass-maeting resolutions (when ratified by NHG/SIGS)

- (B) By- laws Amendments
- (P) Policy
- (C) Critical Reviews and Greviences (proposals only)
- (A) Action Programs
- (0) Organizational Matters
- (E) Emergency Mass-meeting resolutions

Each of the above "books" shall be further catagorized as may be necessary (according to areas of interest). This committee shall maintain a complete master list with cross-references and shall issue reports on tabulations in numbered sheets so that any individual who wishes to accumulate resolutions and keep book may do so.

PROPOSALS TO COUNTY COUNCIL FOR VOTE BY NEIGHBORHOOD GROUPS

- If more than two-thirds, but less than all of the groups have voted on an issue, those groups which have not voted on the issue should be allowed one (1) additional week in which to vote on that issue so that their votes on that issue will be recorded.
- 2. With regard to Proposal #111 of last week's agenda, we hereby submit this Proposal:

That the voluntary monthly donation for each active member of the peace and freedom movement be increased to \$1.50 and that two-thirds of the monies collected be turned in to the County Finance Committee, and that the remaining one-third be used as necessary by the individual neighborhood groups. And further, that the proper quota for each group not be in the form of required individual dues, but shall be met by each neighborhood group by any other means they deem necessary.

THE HOPPLR PLAN A proposal sent up from a neighborhood group should be printed in The Moving Hand, * a weekly record of current proposals-in-process. This proposal should then be dealt with on the neighborhood level by each and every neighborhood group in San Francisco County. Any group's proposed amendments to the motion, or proposed substitute motions, should then go into next issue of The Moving Hand for dissemination to neighborhood groups. Their final votes on the complete proposition (including amendments and/or substitutes proposed by groups) would finally go into the Hopper (a bin or box used for this purpose) for county-wide totalling of of individual votes cast at neighborhood meetings. (Note: See Section III, below, for explanation of the slightly unusual title of the weekly mimeographed record.) I. Cutline of How This Plan Would Work (1.) An Individual writes a proposal, and takes it to his Neighborhood Group. (2.) His Neighborhood Group votes to decide whether they will forward it ... (3.) To the Hopper, from which it will be printed in The Moving Hand. (4.) Then the Hand will take it to the Neighborhood Groups

- (4.) Then the <u>Hand</u> will take it to the Neighborhood Groups for discussion, and for proposing amendments or substitute motions (which must be passed by a Neighborhood Group to be considered).
- (5.) These all would be dumped in the Hooper again, and printed in next week's Moving Hand.
- (6.) The <u>Hand</u> would take the original motion, plus any proposed amendments or substitutes passed by a Group, back to all the Neighborhood Groups for final vote.
- (7.) The neighborhood votes would be dropped into the Hopper totalled county-wide, and the results would be reported in The Moving Hand.

II. Notes on the Outline

(1.) An Individual writes a proposal, and takes it to his Neighborhood Group.

A. he would draw up his proposal in the form of a motion, resolution, or policy statement, clearly and briefly.

B. Efficiency and courtesy suggest he should provide enough copies for the members of his Neighborhood Group, and that he should be prepared to discuss his proposal.

(2.) His Neighborhood Group votes to decide whether they will forward it...

A. The Group should vote, this time, on whether they think the proposal is worthy of consideration. If the proposal is unclear or self-contradictory, they should tell the proposer to rewrite it. As for deciding whether the proposal should be passed or defeated, their chance will come later, when all neighborhood groups vote on the proposal.

B. Cur policy is that all proposals should come from .. the neighborhood level. It would be up to the maker of the proposal to convince his group that his proposal was worthy of consideration county-wide. If he feels his group unfairly squelches his proposals, he should join a different group, or organize a new one.

(3.) To the Hopper, from which it will be printed in The Moving Hand.

A. It should be signed by the delegate and put into the Hopper no later than the end of Monday's County Council Meeting. The Council may discuss or debate the proposal, if delegates want to, but cannot take any action in it.

B. The Publicity Committee would print it in The Moving Hand on Tuesday morning. It would go under the heading of "New Proposals". This is its "First Printing."

(4.) Then the Hand will take it to the Neighborhood Groups for discussion, and for proposing amendments or substitute motion: (which must be passed by a Neighborhood Group to be considered.)

A. The delegates could lobby, and bring up pertinent points which they learned from the debate (if any) at the County Council meeting.

(5.) These all would be dumped in the Hopper again, and printed in the next week's Moving hand.

A. Once more these should be signed by the delegate. B. The proposal, etc., would be printed in The Moving Hand; this would be the "becond Printing" of the proposal, under the heading of "Old Proposals".

(6.) The Hand would take the original motion, plus any proposed amendments or substitutes passed by a Group, back to all the Neighborhood Groups for final vote.

A. Each Neighborhood Group would then conduct its final

vote on the proposal, etc.

B. Everything should be voted on at this time -- the original proposal, any proposed amendments, and any proposed substitute motions.

C. The individual votes should be clearly recorded (by the delegate) in numbers, with four possible ways for each individual to vote on each original proposal, each amendment, and each substitute: PASS; REJECT; ABSTAIN; or TABLE (for another week

D. Meaning of the votes: If a majority of individual votes, county-wide, are PASS, then the item is passed by San Francisco County Peace and Freedom Movement. If a majority of the votes are REJECT, then the item is definitely defeated by SF/PFM; and the item cannot be proposed again until at least one month has passed. If the majority of the votes are ASSTAIN, then SF/PFI has decided there will be no official position on the item, at least for the present. If the majority of votes are TABLE, then the so-called "final vote" must be followed by a "repeat vote" in the following week. If none of the four possible votes (PASS, REJECT, AESTAIN, or TABLE) gets a majority, then there shall be a repeat vote. When a repeat vote is held, there shall be only two ways to vote--PASS or REJECT.

(7.) The neighborhood votes would be dropped into the Hopper, totaled County wide, and the results would be reported in the Moving Hand.

A. The delegate of each group will prepare a report of the votes, sign it, and place it in the Hopper.

B. The Publicity Committee will add together all the individual votes, county-wide; not by group.

III. The Moving hand

A. The timeographed record of current proposals-in-progress would be divided in two parts:

(1) New Proposals. First time printed in the record; should indicate the title of the proposal and the neighborhood group and the maker.

(2) Old Proposals: the form would be the same. Amendments and substitutes should have their makers' names on them as well as their groups. Spaces should be provided by each proposal or amendment, where anyone can easily record the number of votes.

(3) The record of proposals-in-progress will NOT be the minutes of the County Council, NCR the Council's agenda: those have separate and distinct functions. NCR will this record be useful as a County Newsletter, as it won't contain much news.

useful as a County Newsletter, as it won't contain much news.

(4) For clarity and ease of remembering, the record of proposals-in-progress (which will be a weekly bulletin, rather dull to read) should have a catchy title which clearly distinguishes it from such other documents as the minutes, the agenda, the county newsletter, etc.

Another reason for an inusual title is this: Bureaucratese is an ugly language. We should try to use vigorous English whenever we get the chance.

That's why we picked The Moving Mand as the title of the record. ("Belshazzar the king made a great feast....In the same hour came forth fingers of a man's hand, and wrote...upon the wall of the king's palace...And this is the writing that was written, MENE, MENE, TEMEL, JPHARDIN. This is the interpretation of the thing: MENE; God hath numbered they kingdom, and finished it. TEMEL; Thou art weighed in the balances, and art found wanting. PERES; Thy kingdom is divided, and given to the Medes and Persians. --Daniel 5: 1-28.)

That we support Reies Tijerina and other Alianza leaders in their fight for liberation.


