Fund Raising reports on the 'Mac Bird' benefit to be held at the Geary Temple theater (1859 Geary) on Fri-May 10-8pm. Tickets on sale at Colton St.

There will be no benefit on 5/15 as announced. There may be a benefit for Dick Gregory on that night. Announcement soon.

18-Year-Old-Initiative is moving vetter in small counties than in SF. Emphasize the fact that the move for signatures could be furthered if each P&F member would carry a petition.

A leaflet is being printed on why 18-year-olds should have the vote - out by the end of the week. Bumper stickers available at Colton St.

Wed and Thurs. will be a Board of Supervisors meeting at City Hall (or Norse Auditorium). A good audience for collecting signatures.

Stressed that a woman must sign Miss or Mrs. on the petition. It is a legal technicality.

Office reports that they have petitions in the office which will be given to all qualified persons wishing to circulate them.

Still needed are the names of each NHG/SIG emergency secretary and the names of

Volunteers are needed to help in the office.

Stress on the importance of collecting 'Dollar Dues' from P&F members. A necessity

for giving the party a financial base from which to operate.

Labor Committee will have a contingent in the May 25 caravan to Delano. An organization meeting will be held Sat - May 11 - 8pm at the Labor Temple at 16th and Capp Sts.

Publicity reports the Peace and Freedom newspaper will be out Wed - May 8, but still in limited edition to see how well it goes.

A P&F Review meeting to set up a pro-tem staff to work and a review board will be held Sat - May 11- 10am at Colton St. Open to all interested persons willing to serve as staff or as members of the board. A member of each NHC/SIG is requested.

Submission deadline for the next issue will be Sat - May 11 - noon. There will then be a five day period during which all material will be open for inspection. On Thurs 5/16 a formal meeting of staff and Review board will be held for determining what will be printed in the Review of that which has been submitted.

State Steering Committee reports on National Organizing meeting held in Michigan. Three representatives from California on their way by car were involved in an accident which resulted in the death of Chuck Herrick (Alameda County).

Three alternate delegates flow to Michigan. Michigan has received 13,000 signatures on its petition to get on the ballot. Meeting called to discuss the possibility of

organizing a national convention to endorse a Presidential candidate.

Washington State held a convention with 450 delegates attending. A platform with Vietnam Withdrawal, Abolition of the Draft, Full support of minority groups, etc. was adopted.

Kentucky, Virginia, Wisconsin, West Virginia, Illinois, Pennsylvanis, Utah and Nevada all have some forms of a "P&F" movement. General rundown on the forms the various states are taking to institute their "Peace & Freedom" parties then followed, with an explanation of some of the internal struggles going on with in them.

Mike Delacore and Carlos Aponti have been sent as National Organizers to states around the country who are trying to form parties along the lines of P&F. There have been suggestions that perhaps we should keep our money in California instead of trying to organize nationally. Countered with the report that money being spent is minimal and donations are being raised by the individuals involved. In the case of Carlos Aponti: he is being supported by the New York Peace and Freedom Party.

Suggestion that if more states are involved there should be a better chance of raising money for the party in California and the party as a whole.

The next P&F newspaper will carry a report on National Organizing.

Co-Ordinating Committee announces that Proposals Committee work sessions will be held at Colton St. on Tues at 7:30pm in the NHG/SIG office. A general meeting will be held at 7pm on Wed - May 8.

Elections Committee will meet May 7 - 8pm at Colton st, Registrar has sent out lists of registrants by district... to be used for organizing the election campaign. Next week a special edition of the P&F newspaper will be published specifically

for giving out information on the election and the candidates.

The 23rd Assembly District because of an action on the part of a group of individuals in the Eureka-Noe Valley NHG will not have a candidate. It is suggested that those individuals come up with a candidate by next week.

Offices have been built at Colton St. The NHG/SIG office will be used as a service

center for the NHG/SIG. But the interior decorating will be up to them.

Duties of the CC and its relationship to the Work Committees: Work Comm. are the ongoing arm of the CC. Policy making lies with the NHG/SIG. CC has implementation powers of those policies. The Work Comms, are the form in which the CC implements policy formed by the NHG/SIG. The work Comms. are responsible to the CC. The CC can, at any time they are dissatisfied, becoume the committee as a whole to either reverse or negate implementation begun by the work comms.

Discussion: Points made —

To much assuming on the part of the Co-Ordinating omm in interpreting the by-laws. The by-laws are ambiguous, but proposals have been submitted to change them.

Makes no difference whether by-laws are changed or not, the NHG/SIG will continue to do as they please. The problem is not what they are doing, but why.

We have a structure that does not work - this would act as a cohesive factor... bringing the NHG/SIG and the CC closer together.

This body functions through its comms. and will not place itself in jepordy by accepting the Co-Ordinating Comm. interpretation of the by-laws. That what it means is that the CC will have power.

If the NHG/SIG would vote and participate all this would not be necessary. That proposals #229 and #230 would cover the problem and are a case in point that the NHG/

SIG are not doing their job.

Somebody is exercising power at the present time. Who? Policy decisions are made by the NHG/SIG. No comm. or the Co-ordinating Comm. have made policy. The NHG/SIG can do any damn thing it wants to unless it clearly contradicts the policy of the County. And the County policy may differ form the State as long as at the time the County policy is stated it is made clear that it is in opposition to that of the state.

Essential that we straighten out a structure that permits us to do absolutely nothing. Not confusing policy issues with implementation of those policy issues.

In essance we will be doing nothing but giving the CC power.

Yes, it would. But power would not be taken from the NHG/SIG. It would give the NHG/SIG a chance to do the work of implementing their policy through the CC. The

CC will still be responsible to the NHG/SIG.

MCTION - That all policy making power lies within the NHG/SIG. hat the function fo the CC is to implement those policy decisions. That the CC has created administrative committees to fulfill this function, and that the administrative committees are directly responsible to the CC.

CC constitutes itself as the Program Implementation Committee (PIC).

Points made:

Because of the importance of the 18 year-old initiative (18 yoi)we should use this body as an arm for organizing that drive. June 7 is the deadline with the 10 day period following as an extension if needed.

Initiative drive will not succeed unless the drive is directed and PIC

is in a position to do that effectively.

When the 18yoi first broke no one was in favor of it... Reasons still applicable... we have better things to do... elections campaigns should have some priority.

Should be discussing what programs into which we should put our ener-

gies and how to implement those programs.

Our main job is to fight people like Kennedy and McCarthy.

18 you drive will make a lot of people like us but doesn't mean they will join P&F. we should go into fighting issues.

There are people such as those fighting for rent control in the Mission

Tenants Union that need our support.

We need to work on issues that can carry us over to November.

What we need is issues and people to carry us over ... not to just Novebut to 1970 and 1972 and 1986... the eighteen you can help us with that

whole at the same time we can lobby for our local issues.

A poll taken in Riverside at a High School fair shows that 8% of the young people related to the American Independent Party, 16% to the Republican Party, 20% to the Democratic Party, and 54% to the Peace & Freedom Party...those young people relate to P&F and we should make an effort to relate to them.

Issues should be exciting enough for adults and young people, not

just dishwashing jobs but the hard jobs as well.

All causes are worthy but 18yoi is an attempt which will tap our resourses exclusively.

We have made a committment and we have a responsibility to keep that

committment.

A very difficult project...as of now we won't make it. In LA a 1000 people are circula ting petitions, if we don't help with some concentrated effort they will be turned off. Instead of just passing resolutions we must make an effort to follow through.

We are talking about people who are dying and don't have a thing to

say about it.

This was brought up at the convention as a state wide issue which would involve all the NHG/SIG in California...while getting signatures

it is possible to talk politic s.

We do have the time - until June 7 the 18yoi drive and after full concentration on local issues...to feel it is animpossible taskwill just create feelings of frustration within the NHG/SIG.

What about the people over 21 who need us to work on their issues.

The initiative is clearly identified as a P&F program...the final push of the registration drive is what put us over the top.

The rent control initiative petition could also be circulated at the

same time, although not by the same people (illegal).

We are involved in electoral politics...if we succeed in the 18yoi we will have access to 18-21 yr. olds who because of our help to them, will help us.

The LA delegation at the convention blackmailed us into passing this... that doesn't mean we must follow...being registered won't stop the war

and we shouldn't give that illusion.

We should stop this discussion and work on other projects that serve the needs of the people, i.e. rent control, black liberation, strike support, educational struggles.

Has its merit, especially good for going door to door and introducing

new people to P&FP.

The Fillmore will need 500 signatures to write in Kathleen Cleaver and must put all its energy into that project...the time deadlines conflict.

All issues are important but creating conflict that doesn't exist... all people signing 18yoi petition are people who are involved in the other issues...they are the same people...where is the conflict?...A broad issue...will help in building an ongoing organization.

as the FIC with the task of organizing the 18 you drive as its priority,

Because feeling around state is infavor of an endorsement, we will work in California to endorse a candidate that we can present to other states for their support. It is requested that a Mass Nominating Convention be held in in late July to nominate not only a presidential and Vice-presidential candidate but also a slate of candidates for a shadow cabinate.
