TRIAL BY PRESS

Let's talk sense about the events that took place in the Gater office November 6.

The only fact that is known for sure is that a fight occurred.

The only source of information about the incident so far has been from one of the participants, namely the Gater editor and his staff.

We have seen photographs showing a fight in the Gater office. The pictures do not show a premeditated attack on the Gater editor by a group of black students. All they show is a fight. The Gater's interpretation of the pictures is only one of a great number of possible interpretations. We do not pretend to know what happened, but after reading the utter racist editorial by Jim Vaszko in Friday's Gater, we feel that one explanation could be that the fight was provoked by an offensive remark or act that Monday by Vaszko.

What gives the Gater the right to set itself up as prosecutor, judge, and jury of the Black Student Union and to declare that, "we no longer intend to tolerate the Black Student Union as it is now organized."

Who decides which evidence is valid and which is not?

We question the objectivity of an edicor who can produce such vicious statements as: "...it (BSU) not only preaches hate, destruction and violence, but practices it as well."

The Gater last week give us a shining example of journalistic witch-hunting with its hall by press of the BSU. We repeat, we do not know the facts are not making any judgments about what happened until the facts are known, but the Young Socialist Alliance calls on all the facts at San Francisco State College to repudiate the Gater for this frial by press and for its vicious racist attack on the Black Student Union in Friday's editorial.

The Gater has shown itself to be as much a part of the racist establishment of this society as the San Francisco Examiner.

Not only has the Gater attacked the BSU, but it has opened up an attack on other student groups: the C.I.P., the Experimental College, and the work-study and tutorial programs. The Young Socialist Alliance feels that an attack on one student organization is an attack on all.

Students on this campus, including black students, pay over \$32,000 a year to support the Gater. The least we deserve in return is accurate and unbiased reporting on the ideas and activities of student organizations. We do not deserve the bicard "leatablishment" reporting that

On Friday, November 10th, the Community Involvement Program was slandered by the Gater. This is not the first time that the CIP has been the victim of misinformation on the part of the Gater - nor is it the only program to be damaged by the irresponsibility of members of that paper's staff. Friday's edition, however, was a blatant example of how one individual can make a vindictive tool out of this newspaper to strike out at whomever and whatever he wishes without the slightest regard for his obligations to his readers in terms of truthfulness or objectivity.

Mr. Vaszko has misused his powers as editor of the Gater, powers of which we seriously doubt he has the least comprehension. Not only must these powers be immediately withdrawn but we, as members of the SFSC community, must look closely into how such an irresponsible individual obtained such a potentially dangerous toy to play with. A daily publication can be an extremely valuable asset to our campus, IF IT IS HANDLED RESPONSIBLY and IF IT IS RESPONSIVE TO THE WHOLE CAMPUS. We feel that this can only be accomplished by a complete break with the Journalism Department and an editor elected by the student body.

There is no point in repeating here the chargcs against the Gater. They have been published and substantiated, republished and resubstantiated for many years, and the Board of Publications has still unfailingly ignored them, or rejected them with undisguised contempt.

Instead, we must understand the role the Gater plays with respect to other events around us—whether war recruiters on campus, student employees drive for better working conditions, or the fact that racism is as strong (though better hidden) on this campus as in any community in the U.S. And the Gater has not only failed to deal with these problems, it has been a main source of many of them.

For the Gater, though it can sometimes afford to be more "liberal" than most, is merely the local house organ of a political and economic system which uses the presses—as it uses all other media—to defend its own ideology, justify its repression of two-thirds of the world's population, and confuse and divide the people with its lies and distortions.

We do not propose that responsibility for the Gater be shifted from one elite in the journalism department to another elite someplace else, but rather that the largest number of students be involved in the struggle to make the Gater directly responsible to the student body. For the problem of the Gater is merely a small reflection of conditions existing nation-wide, and this problem will not begin to be solved until there is wide-spread struggle to solve it, not only on this campus, but everywhere.

THE GATER AND THE FOUNDATION

On November 10, 1967, the Foundation Board, composed of students, faculty and administrators, voted unanimously to send its chairman to the Board of Publications to report the serious inaccuracies in the <u>Gater</u> coverage of the Foundation.

In the past few weeks the <u>Gater</u> has printed articles on the Foundation, its labor contract with the <u>Organization</u> of Student Employees, and its relation to the <u>College Union Project</u>. These articles contained numerous inaccurate and false statements.

Many of the Gater's errors were due to carelessness, but the most serious were deliberate lies designed to create antagonism toward the Board.

The Gater's handling of Foundation news culminated in a November 6, editorial entitled "A Student Money Grab."
The editorial charged the Board with irresponsibility and supported the charge with the following statements all of which are false:

- -- The Foundation "decided to raise wages rather than lower prices."
- -- The Foundation has made the College Union "more expensive to finance."
- -- The O.S.E. wage increase has "thrust a new financial burden on the general student body."

The November 6, editorial is but one more example of how the Gater is often used to create senseless antagonisms among students.

Peter Pursley Chairman, Foundation Board of Governors The College Union Council is taking this opportunity to clarify several issues which have been confused by recent Gater coverage of the College Union Project. An editorial on 11/6 and articles on 10/27, 11/2, 3, and 6 are involved. (We retain confidence in the integrity of John Davidson, the Gater reporter assigned to the College Union project, and consider the responsibility for the lies and resulting confusion to be the editorial staff's.)

First, the Gater has stated and implied that the College Union project is in "peril" because of financial problems. This is a lie. The financial problems of the College Union are complicated, but in no way insoluble.

Secondly, the Gater has stated and implied that the SFSC Foundation is no longer a source of funds for the College Union project. This is a lie. The issue is to decide on the most feasible and responsible financial relationship between the Foundation and the College Union.

Thirdly, the Gater has stated and implied that the recent OSE wage increase is responsible for the College Union project's "peril." This is a lie. As stated previously, the project is not in peril.

Fourthly, the Gater used the aforementioned lies to support its political bias during the Foundation Board of Governors' election in October.

In general, we totally disdain Gater coverage of the College Union project and invite interested students to come to our office in Hut C for information.

4. Any Union that does not attempt to improve wages and working conditions for its membership should not exist.

The Gater has suggested that 0.8.E. should not exist.

5. There is a myth which encompasses all Gater articles concerning O.S.E. It is the idea that anystudent who works his way through college should be kept in a position of financial dependence which verges on poverty. The perpetuation of this myth by the Gater causes working students to be treated as second class citizens.

With the above motives the Gater has accused 0.S.-. of:(1) causing financial setbacks to the College Union, in spite of the fact that no one involved in the College Union has presented such charges, in fact the College Union Chairman has repudiated the Gater's charge; (2) The Gater has implied that a \$1.85 is a living wage for student part/time work. 0.S.E. contends that \$2.25 is approaching a living wage; (3) The Gater has constatntly misrepresented 0.S.E.'s negotiating intentions with the Foundation.0.S.E. has been willing to settle its differences with the Foundation without resorting to a strike and in fact has accomplished this end.

The G-ter has usurped its proper function when it becomes a one-sided power bloc utilizing the power of the press to present an individuals feelings as being representative of the student community. Need you be reminded of the editorial published on Friday,

Nov.19?

A more recent example of lies, halftruths and irrationality appears in the Garer on Tuesday, Nov.14, 1967, in an article written by Dan Moore, city editor of the Gater. "It isn't possible for Vaszko to differ, for instance with the Organization of Student Employees (O.S. .) on anything other than political grounds. The only explanation for an editorial against a\$2.25 w ge, they t ink, is because Vaszko is a yellow fascist journalist. The article referred to is evidently a letter to the editor written by Albert Duro published Monday, Mov. 13, 1967. The apparent misrepresentation is manifold: the Letter is from an individual member of O.S.#. and does not represent O.S.E., although most members will agree with Al's criticism of the Gater: Moore misquotes the article, it should read "fascist yellow journalism" Moore also says that the quote refers

to the type of journalism most provalent in the Gater; Moore rationalizes the editorial by Duro as being an attack upon Vaszko's stand against a \$2.25 hourly wage. This again is untrue. Duro and O.S.E.'s criticism of Vaszko's editorial, Monday, November 6, 1967, centers upon the lies and misrepresentation of facts which the editorial states.

Vaszko's editorial accuses 77 students (C.S.E.) of cheating 18,000 students out of a College Union. This misrepresentation has been refuted by the College Union Council Chairman. The article also implies that the 77 students are the only ones affected by the \$2.25 hour wage. The article fails to mention that the students in the Bookstore will receive that same amount. It also fails to mention that all non-student employees in both the Commons and the Bookstore, who are receiving less than

\$2.25 per hour will be given an increase up to that amount.

Vaszko says "But he (Dorn Campbell, O.S.E. President) fails to mention that busboys in the culinary union local are getting only \$2.15 per hour." This is another lie. According to the wage scale of Waitresses and Cafeteria Workers' Union, Local No. 48, effective September 1, 1966, under the subtitle Bus Boys and Bus Girls, "2 hours or less (lunch only) - \$6.55, 3 hours straight or less - \$8.00, 4 hours straight - \$10.00." The lowest paid "busboy" is one who works $7\frac{1}{2}$ hours within 12 hours, he receives \$16.80 or \$2.24 per hour. One must keep in mind this contract expired September 1, 1967, and a raise was more than likely granted.

In the same editorial it is implied that the 77 students employed at the Commons are "busboys." Again this is more bull-shit. There are counter workers, salad, and sandwich makers, service fountain people (Hole-in-the-Wall), combination busboys and dishwashers, dish-up people, and cashiers. It is interesting to note that these people,

according to the above cited reference, all receive higher wages than busboys.


The Gater is upset because we will receive two free meals after an employee has worked "only four and one-half hours." I could cite the above agreement, but I think by now the message is clear.

POlitiCS AND PROCESS

In suspending the AS-subsidized underground weekly, Open Process, President John Summerskill took the logical step dictated by the hard facts of California politics. Under unrelenting pressure from reactionary politicians in Sacramento and Chancellorville, the president this week bowed under the yoke of Max Rafferty and Ronald Reagan, suppressed a student newspaper, and suspended two student staff members, without hearings or due process.

As pressure outside the campus mounted, Summerskill found that he not only had to submit himself to the ire and outrage of Rafferty and Reagan, but also had to suffer the sniping of a two-bit Peninsula politician, Leo J. Ryan, who has turned Open Process into a money-raising, tub-thumping campaign issue for his re-election to the Assembly.

Naturally reluctant to smear his own hands with the blood of Open Process, Summerskill first attempted to persuade the Board of Publications to do his hatchet work; twice he convened this body in emergency session to press for suspension, but when the BOP expressed its intent to follow due process, Summerskill plunged the knife himself. With a meeting of the Trustees scheduled this week, the president had to be assured the media would carry reports of his firm stand against dissidents, even if his actions were high-handed and unjust.

In short, Summerskill came to realize this week that it is not his job as president to represent the interests of the students and the faculty, nor to maintain a campus open to the expression of ideas; he is here to carry out the orders of his superiors in Sacramento. Despite his well-known and oft-expressed liberal leanings, he now realizes he is the servant of the state, not the protector of the students.

Looking at the issue dispassionately, the printing of a few lines of erotic verse hardly justifies the vehement expressions of indignation that have swept the faculty and administration since the appearance of the latest Open Process.

The students at S.F. State have reading matter available to them on campus that includes publications which are frequently sexually explicit: The Barb, Oracle, Realist, even Playboy occasionally indulges its readers with an outlawed Anglo-Saxonism. Nobody can realistically expect students here to be shocked by Jefferson Poland, nudism, or what passes in contemporary society for obscenity.

Open Process was not the victim of student wrath; it suffers at the hands of purblind Sacramento politicians who see nothing inconsistent with the suppression of

student newspapers and the concept of free speech and a free press.

Tactically, the suppression of Open Process and its editor is sound from the administration's standpoint. Summerskill can be almost assured of looking strong in Sacramento without suffering campus consequences such as the disturbances that have shaken other colleges over issues such as race and the war. He feels confident he can capitalize on the indifference and apathy of a jaded student body.

The only thing that can save Open Process from the grave is concerted action by students who are willing to make their displeasure with the peremptory, cavalier, and politically motivated actions of the administration against their paper known both to

the campus and the community. Speak up. While you still can.

THE STUDENT'S RIGHT TO LEARN

At 4:45 p.m. on November 28, Blair Paltridge and Jeff Poland received a call from Dean Reddell's office informing them that they were being suspended by President Summerskill...that they were to come to the administration office to pick up the letters of suspension...that John Summerskill was leaving immediately to meet with the Trustees in Los Angeles and could not be seen until he returned from that meeting ...

No legal hearing. No channel for redress. No concern for negotiation or reconciliation. When Blair Paltridge was selected by the Board of Publications to be editor of Open Process, he told that body that to the best of his ability he would make O.P. a medium worthy of the diverse and complex talents of student and faculty expression.

This has not been the intent of the editor alone; it has been the express condern of the entire O.P. staff from its inception. If we have failed anywhere it has been in not being more radically committed to fulfilling that function (and because more members of the college community have not made use of the paper). But what is really implied by that commitment is the willingness to learn. Paltridge as an editor is committed to the open process as a medium of student learning. Obviously, in a society where higher education is set against a background of systematic oppression and violent suppression, the student's freedom to learn is in serious question.

In light of the absurd and tragic political action of suspending students for the expression of ideas that are alien to the political forces outside the campus, can any student feel assured of any real learning experience while attending this institution? And this is, surely, what we are all involved in. To learn what is most relevant to each of us in order to survive and to create a sane world for our children. If this is true, then we must act now in order to assert every student's right to learn whatever he can -- even at the risk of making a few mistakes now and then.

During the War Crisis Convocation, this campus voted for Free Speech. In accepting the petition from Students to Kepp the Campus Open, President Summerskill said that he believed in an open campus wherein many divergent views could be expressed.

But on November 28 he yielded to outside political presure by suspending Open Process and two of its staff members. In so doing he not only contradicted his own earlier statement; he also violated Resolution #22, passed by the Convocation, which states, "No member of the campus community shall be suspended, expelled, or dismissed for the exercise of any civil right."

We don't know who might be next to go. If President Summerskill's action sets a precedent, any time political pressure is put on him from outside the campus to do so, nothing will keep him from violating our rights of free speech, free press, and due process.

Nothing, that is, unless we do something now to let him know we don't like it. We came here to be educated, to be exposed to all points of view, and to learn to be citizens of a free society. We didn't come to be "protected" from anything someone else has decided is "offensive."

TIRED OF TILTING AT WINDMILLERS?

Professor Gerassi was hired by the International Relations Department with full knowledge of his political beliefs and was allowed to teach in accordance with these beliefs.

On Wednesday, December 6, 1967, Professor Gerassi took an action in furtherance of his beliefs, by joining with students in asserting their right to enter the Administration Building to press for their demands.

Immediately thereafter Professors Windmiller and Whitaker, despite their professed belief in academic freedom recommended the suspension of Professor Gerassi, thereby denying students their right to continue classes with him. This hypocritical action exposes their willingness to allow freedom of expression only so long as nothing is done to make such expression effective.

The charge against Professor Gerassi is "unprofessional conduct." These gentlemen apparently believe that living one's convictions is unprofessional, and they prove it by not living up to theirs - violating academic freedom and disregarding the interests of the students. Isn't this typical of our campus liberals? This is the same Windmiller who initiated the docking of pay from members of the International Relations Department faculty who left the campus to participate in Oakland Stop-the-Draft-Week activities.

- 6. The general staff has the rights to teach and implement decisions in order to carry out the above policy statements.
- 7. There shall be no censorship of student publications. Any complainsts regarding content of the paper will be referred to a duly constituted student court.
- 8. Any group of one hundred or more students shall have access to paper and a printing press or mimeograph machine, without restriction of zentent and free of charge.

MOVEMENT AGAINST POLITICAL SUSPENSIONS DEC. 22 & 23, 1967

To all California campus anti-war groups:

It is now apparent that for the last few weeks the anti-war movemovement has been under a new and intense attack. Student leaders all across the nation have been suspended and expelled from school for minor infractions of rules or simply excerising their constitutional rights of free speech and organization. In all cases there has been no recourse to due process within the university structure or legal redress. Court fights are almost always unsuccessful but perhaps given months of expensive court fights we may gain protection from the arbitrarily harsh punishments of university adminstrators acting in complicity with the warmakers. But we must act now!

We at Berkeley call an emergency meeting of all college and university anti-war groups in California. We must seek methods for the protection of our leadership and defense of student political rights. We invite all interested persons to attend a conference in Berkeley on December 22 and 23 to discuss the current crisis and formulate a common defense.

Mass disruption alone has not protected our leadership or student political rights. Now we must formulate new tactics and form a united front against this attack against our movement. Unless we are able to mobilize and act, our leadership will be destroyed and our rights oppressed.
