# The Resistance

Today Vietnamese men, women and children will die. They will die at the end of an American soldier's bayonet, they will burn to death from the napalm dropped from American planes. These executions are performed daily by ordinary American guys, most of whom are NOT in Vietnam by choice. They were drafted. Our government ordered them there.

What can we do about these crimes??

Is it enough to sign a petition, continue working toward our degree, and living a "normal" and happy life? Every American who feels strongly about the Vietnamese war must ask himself these questions.

The number of young Americans who copose this war and wish no part of it increases daily. But for men of draft age the alternatives to conscription are few. If they are without student deferment and will not or cannot fake their way out, they can only apply for C.O. status. The great majority of those who apply for C.O. status are eventually turned down. Then the only alternative to military service is jail. However, those most active in their opposition to the war have deferments; either because they are students or because of their unwanted politics.

THE RESISTANCE is a group of men who feel we can no longer passively accept our deferments so that others can go in our place. We REFUSE to cooperate with the draft and urge all other American men to join us. We are convinced that there are enough men seriously opposed to the war that a significant, political effect would result if we stood up TOGETHER and refused to cooperate with the system that perpetrates murder in our name. We believe that only by doing so will we be in a position to speak to young Americans who are faced with the draft. We would like every American man to realize that he must make a moral choice as to whether he will allow himself to be used to commit war crimes.

We are organizing now in preparation for our action in the fall. On October 16, several hundred of us across the country will inform the government in a dramatic way that cannot be ignored, that we REFUSE all cooperation with the draft. We will clearly challenge the government's right to use any American lives for its war against the Vietnamese people. Further, our challenge will continue, and we will openly violate the selective service laws until the government is forced to deal with our collective protest. Anyone of us singled out for arrest can be assured that we will stand together with him. For example, we intend to file confessions at the police stations stating that we ALSO have violated the selective service act. We are confident that upon our example every young man in America will realize that HE must decide whether to resist or acquiese to the draft and the war. Many will resist.

The price of our refusal--which we are prepared to pay--will more than likely be a jail sentence. But compared to the price that Vietnamese people pay daily for refusing to 'cooperate' with the American government, our price is small, indeed.



GREETING:

### THIS IS WHAT IT FEELS LIKE

I received the above Induction Notice early Wednesday morning; a final communication from the system which I have decided I can no longer co-operate with and am determined to resist. Together with the rest of you I've announced my active non-complicity with this war of atrocity and deceit in Vietnam, and together with you I affirm the living truth of the love between men and God which is so desparately lacking at this time. I will enact and realize these convictions on the fourteenth of December; refusing induction, and counseling my brothers in the Center to do the same. I shall not be silent - words come hard to me, but I'll find them as best I can. I'm scared; nervous and apprehensive about appearing in front of so many people in such a highly visable fashion at such a time, concerned about the response of my beloved family and friends to my act, even defensive about my motives and rightness in action. I am not free from doubt. Nevertheless, afraid as I am, I shall act, and ask that as many of you as may, join me in an act of resistance and affirmation which I hope will stand with others of its kind in the face of the peculiar sterility which characterizes the bloodshed and tragedy of our time and society. I ask that if you come you come in peace - that we neither chant slogans nor hurl invectives at our supposed enemies, for I have no hatred for men far more lonely and frightened than I. I ask that you assemble with me at 6:30 A. M. in front of the Oakland Induction Center in quiet affirmation of the act, and acceptance of its consequences. A free man's freedom is a gift which can not be taken away by man - only given by God and realized through acts.

THE TIME HAS COME when conscience can no longer be denied. The time has come when young men can no longer be satiated by draft deferments from the selective service system. The time has come when we must stand together and refuse association with a system as corrupt and perverted as is the present governing body of this country. The time has come when we must invest our lives for posterity. The time has come to resist!

On October 16th, well over a thousand people refused to allow the federal government to determine their lives or commit murder in their name. This was accomplished through an act of non-cooperation vis-a-vis the returning of individual draft cards. Today, these people are subject to prosecution for refusing to cooperate with the selective service system of this country. These people can no longer participate in any way towards the maintenance of the American war machine. These people believe that it is better to obey the will of God than the laws of man.

We invite you to join us in our war. It is not a war against a small under-developed nation struggling for the right of self-determination, but a war against the misery, tragedy and dealth which runs rampant in the world today. It is a war for our right as individuals to determine how we will lead our lives.

I urge you to consider the effect non-cooperation will have on your total life. I believe the effect will be phenomenal for, by joining us, you are joining the forces of good on this earth. If you subscribe to selective service and indiscriminate murder, you are joining the forces of evil. The choice is yours but - THINK BROTHER!

#### THE FEDERAL BUILDING 1:00 P.M.

On Dec. 4th 1967, members of the Resistance will again gather together to publically and collectively return their draft cards to the Federal Government at the Federal Building, 450 Golden Gate Ave. in San Francisco. Others will place statements of non-cooperation.

These young men will be joined by hundreds of others in New Haven, New York, Chicago, Los Angeles, Denver, Portland, Kansas City, St. Louis, Cincinnati, and many other cities around the nation.

At this second Resistance action, we hope to have not only members of the Resistance, but supporters from the communities they represent, who will join them with visible support.

Since both Grace Cathedral and Glide Memorial Methodist Church have denied the use of their respective buildings for the short worship service of "conscience and acceptance," we will once again use the Federal Building:

But the concept of a church context for the return of draft cards is still very much alive. Clergymen supporting the Resistance feel that since the two church buildings large enough to accomodate our action are closed to us, they will bring the church to the steps of the Federal Government.

At One O'Clock, the inter-faith service, led by a Protestant minister, a Catholic priest, and a Jewish rabbi, will begin. There will be an altar set up on the steps. Instead of a sermon, there will be speeches by David Harris and Robert McAfee Brown.

In place of the Offertory, draft cards will be turned in at the altar in the collection dish. The Resistance feels that turning in cards is a more effective means of protest than burning them, but a lit candle will also be on the altar, and ashes will be placed in a chalice which was made in South Viet-Nam from a U.S. artillery shell casing.

Men who are going to return cards will march single file to the altar and state their names over the public address system.

Needless to say, we hope to make this affair as dignified as possible, since one of the purposes of this type of demonstration is to show the support of the religious community for the desistance.

## DRAFT BOARD REACTION

Exhausting Administrati e Remedies. Many of us will want to enter pleas of not guilty if and when we are arrested, and we will hope to bring in evidence on the illegality of the war, the unconstitutionality of the draft, Nuremburg, etc. Needless to say, judges will not want to allow such evidence, since the people to run this war also give them their jobs. They do not desire this confrontation, and if they can dismiss such embarrassing evidence on technicalities, THEYLWILL. One such opportunity for the judges is not to allow judicial review since "the registrant failed to exhaust his administrative remedies." Unfortunately, many of the steps that would have to be taken tp

exhaust these remedies would be contrary to our position of non-cooperation. Here only your conscience can tell you how far you should or should not cooperate.

Chances are that your board's reaction will be either a I-A classification or a delinquency notice. A delinquency notice should be ignored, since you cannot be inducted without being notified of a classification change. If you are re-classified I-A, however, they will inform you of your right to appeal and your right to a personal appearance. If you choose to "exhaust administrative remedies" you will have to respond. But an appeal or an appearance can be anything you want it to be. For instance, you might appeal to them to resign or join the peace movement. And while appeals and appearances might not offend your sense of non-cooperation, an order to appear for a physical certainly will. And yet that physical, if you already haven't had it, is also part of the "administrat: ve remedies" game, as is induction appearance and refusal. induction appearance and refusal.

Induction Notices. Sooner or later most of us will probably receive greetings from the President, and hin a choice is presented: whether to ignore it, or present ourselves and refuse there.

If you choose to appear, transfers are no problem, even if your board is less than 3000 miles away. Just go to any local board and request it. But if you think the publicity you will receive by refusal will make more impact in your home town, then go back there. It is also a good idea to get as many people as possible to write your board to explain why an induction order is a mistake. If you appear and are asked to leave before you officially refuse, be sure to get an affadavit to that effect.

If you choose to ignore the order, keep two things in mind. The first is the "exhausting remedies" routine," and the second is that the odds on no bail are lower. There is also a chance that at the induction ceremonies, you just might talk somebody else out of going.

#### ARREST AND TRIAL

#### INDICTMENT

Lawyers estimate the interval between refusal and indictment is anywhere from six months to two years, with one year being the average. So you have plenty of time to locate an attorney before you are actually arrested. If you intend to plead not guilty, then this time could be spent with preparing a defense. You might be thinking you know just how you want your case handled, but lawyers do have a way of giving you useful modifications.

Indictment is an invisible process. There is no notification. Consulting a federal attorney in the area where you refused could let you know, but the authorities are not obligated to tell you. 54 (1992) -And they will not tell you ubtil you are actually arrested.

#### LAWYERS

It's best to get in touch with an attorney after you refuse. In the Bay Area we know of about 40 who do draft cases. FEE IS NO PROBLEM. Just because you aren't filthy rich, doesn't mean you cany the secure a good lawyer. The lawyers who handle draft cases are more interested in principles than principal. If you don't know where to the start looking, try: . . .

#### ARREST.

#### ARRAIGNMENT.

The court must give you ample time to find a lawyer before you are forced to plea, so don't be afraid to ask for ample time. 

#### BAIL.

Our lawyers tell us that chances for being released on our own that recognizance are good at this time, especially if you make a point of forcefully asking for it. This is another possible point of confronana alam Liy Lasatan tation. 

#### COURT.

Whatever your plea, keep this in mind about the courts: (1) The courts are a good speakers' platform for your consciences, especially if the courtroom is jammed with supporters and the press.

In retrospect, we see a vital omission: mass income tax refusal. For years a few individuals have refused all or part of their federal tax as a form of protest, usually without being prosecuted.

NOW, it is time for a body of people to stand and state: I

REFUSE SUPPORT for this illegal war and unjust government!

This is what we intend to do, begining Dec. 22 at Port Chicago.

Here we will collect statements from all who feel the time has come to refuse support. We will say to the government (through the news media): If you arrest us now, it will be for refusing to support the War ! This form of civil disobedience the government will feel - a mobilization of conscience into action.

We will inform the IRS we refuse support of the War, and take the appropriate steps, including claiming extra dependents, to insure no tax monies will be withheld.

We feel this is a significant move for the expanding anti-war movement. We urge you to join with us to initiate this campaign - Friday, Dec. 22 - Rally and teach-in 2 p.m. We need your participation, help, and support. (Make checks payable to: Western Mobilization Against War).
