Telegram to Walter Reuther, Washington: (Conf on Poverty, Mayflower Hotel)
We urge you, on behalf of two hundred students already in Mississippi, who
may at any moment be beaten, bombed, ~~or~~ found missing, and on behalf of some
500 more yet to arrive, to seek audience with the President, the Justice Department
and other federal agencies to ask for stationing of special teams of FBI agents,
the placement of federal marshals in critical areas, and whatever other means
are necessary to ensure that all Americans have equal value under the law.
¶ Delay by federal authorities in setting a visible pattern of firm commitment
to uphold basic protection of vote workers will have an irremedial effect on
what happens later this summer.
